

Adjourned Meeting
Monday, Sept. 13-1948

The Council met in session adjourned from Tuesday, Sept. 7 on Monday Sept. 13, 1948 .

Present: Mayor Markee, Atty. Zimmerman, Supt. Raines and Councilmen Cutsforth, Eversole, Johnson, Kraft, Monahan and Perkett.

Absent-Krueger and Makin and the Recorder .

Mayor Markee announced that the meeting was being held for the purpose of discussing and introducing an ordinance calling for a special election to vote for the adoption or rejection of a new City Charter.

Whereupon, on motion by Perkett, seconded by Cutsforth and carried, Ordinance No. 353 was approved, read for the first time, passed on first reading, ordered published and to come up for final action at the regular meeting of the Council to be held on Monday, Oct. 4 ;

said ordinance calling for a special election to be held in Canby on Monday, December 6, 1948, at which time the legal voters of Canby shall have the privilege of adopting or rejecting a new City Charter and repealing all charters and charter amendments previously enacted.

Whereupon the building code ordinance came up for discussion and in connection with this, Councilman Perkett was asked to instruct the Fire Chief to have another door installed in the Quanset hut and to have the present door hung to open out.

The matter of developing the ^{new} City Park lot was then introduced, and on motion by Johnson, seconded by Eversole and carried, it was voted to introduce an ordinance calling for a program of improvement and a five mill tax to run for three consecutive years, the same to be voted on at the special election to be held on December 6-1948.

No other business appearing , the meeting adjourned until Monday, September 27, 1948.

Adjourned Meeting
Monday-Sept. 27-1948

The Council met in session adjourned from Sept 13
Present: Mayor Markee, Atty. Zimmerman, Supt. Raines, the Recorder and Councilmen Eversole, Johnson, Kraft, Makin, Monahan and Perkett.
Absent-Cutsforth and Krueger.

The meeting was held, primarily for the purpose of deciding on a final draft of the new proposed charter.

Mr. Underwood and Mrs. Logan from the office of the League of Oregon Cities were present and their suggestions, in addition to a letter from Mr. Kehrli, embodying some recommendations were of great help in working out several matters, which had been more or less in doubt. After various changes had been agreed upon, it was left to the City Attorney and Recorder to re-type for the attention of the Council at the next regular meeting.

Whereupon Harold Henry, being present, as a committee of one from the Chamber of Commerce presented the idea of forming a recreation district, suggesting that the Council back such a plan, in lieu of asking the voters to vote a special tax to improve Wait Park.

Followed long discussion, pro and con, the matter being left awaiting further information and developments. Adjourned.
