pecial Meeting June 26, 1947

The City Council met in special session on Thursday, June 26 and was called to order at 8.15 P.M.

Present: Mayor Markee, City Treasurer Mangus, Recorder Evans and Councilmen Cutsforth, Eversole, Krueger, Kraft, Makin, Perkett and

Thompson.

The Mayor announced that the meeting had been called to pass on the budget for the coming fiscal year, in conjunction with the Budget Committee and to listen to remonstrances, if any, from the Public. Also to take up any other business that might appear.

It was then moved by Makin. seconded by Gutsforth and carried, that

the Pudget as published he adopted.

Whereupon Ordinance No. 34% levving a tax of # 4385.00 on all taxable property, both real and personal was introduced and passed on it's first reading; ordered posted in three separate and conspicuous places and to come up for final action at the next regular meeting of the Council to be held on Monday, July 7-1947.

Chairman Makin of the Finance Committee then reported that his Committee favored the employment of a full time bookkeeper, who would keep most of the city accounts and with office hours from 9 A.M. to /2 1230 to 5 30

6 P.M. daily-except Saturdays from 9 to 1 P.M.

Whereupon it appearing that there were two applicants for this position, a ballot was taken, resulting in the election of Mrs.

Myra Weston .

Chairman Exergat Eversole of the Folice Committee then reported that there were numerous applications for the job of nightwatchman and that the Committee recomended the appointment of Harry Lehman, who, on motion, seconded and carried was declared appointed.

It was also recommended by the committee that the nightwatchman

be paid \$ 180. per month for an eight hours shift.

Also Jas. Hudson the day man to receive \$ 180 per month, plus 20.00 as Chief of Police, it being understood that Hudson would

act as relief one night each week.

It was also recommended and understood that the nightman would keep up necessary heat in the City Hall and that the dayman would attend to the street signs and curb strips; also that both should keep a record of their activities for the benefit of the Council.
All these recommendations were accepted by vote of the Council.

It was then moved by Wakin seconded and carried, that the plat of the old Wait property (Tod Wait) he accepted and ordered signed by the City Engineer Mr. Milln and that the deed from Geo. Fletcher to certain part of the street adjoining his property and now in use be accepted.

Mayor Markee then announced that the contract for Federal funds amounting to \$ 11200.00 for preliminary surveying and engimeering

for sewer and disposal plant had been signed and delivered.

It then appearing that it would be necessary to appoint a member of the Council to fill the varicancy caused by the death of Craig Dedman, Mr. Clyde Monahan was nominated. It was then moved that nominations be closed and that Mr. Monahan be unanimously elected.

Carried and so ordered, Mr. Monahan to fill out the unexpired term

ending January 1-1949.
