Motion was made, seconded and on vote of the council was approved that the City of Canby accept the new well as a completed job.

Motion was made, seconded and carried that the balance due on the contract, plus charges for approved extra work, amounting to \$583.76, making a total of \$4,510.82 due the firm of Groesbeck and Lovett be allowed. On vote of the council motion carried. Yeas 5, Nays 0.

Engineer Mills presented his bill for engineering fees on the well job amounti to \$223.59.0n motion, sec led and carried payment of this bill was allowed. Yeas 5, Nays 0.

Mr.Lovett expressed his appreciation to the council for their co-operation on the job.

There being no further business, on motion the council adjourned.
