

Regular Meeting.  
August 5th.1940.

The regular monthly meeting of the Council was held Monday August 5th., 8 o'clock P.M. On roll call there were present Mayor Vinyard, Atty. Zimmerman, Chief of Police Hansen, Recorder Mangus and Councilmen Everhart, Gesik, Koehler, Pfister and Porter. Absent Councilmen Cutsforth, Reynolds and Stefani.

Minutes of the regular July meeting were read and approved.

On motion, seconded and carried, Yeas 5-nays 0, the above claims were ordered paid.

Bill of Mr. M.E. Wright's for \$1,300.35, less a credit of \$95.66, for comprehensive liability insurance policy was not allowed, as the figure quoted for this policy was \$1,032.43 for three years, or a cash price of \$955.95.

Mr. Lent reported that the W.P.A. water system project was progressing nicely, also that more work is available. After discussion motion was made, seconded and carried that application be made for the following extensions: the new street in the Dedman addition, a main from the wells to the Park Lots, extend the mains toward the H.B. Evans property and replace the old pipe running south from the rail road tank.

Purchase of the necessary pipe to take care of the above extensions was authorized by vote of the Council. Yeas 5-Nays 0.

Motion was made, seconded and carried that the Supt. be authorized to sell the old pipe that can not be used by the City for 5¢ per foot.

Ben Hansen reported to the Council that new tires was needed on the utility truck. Motion was made, seconded and carried that new front tires be purchased for the truck.

Lester Hess reported the opening of two graves and the sale of two half lots during the month. Councilman Everhart stated that 105' of 3" pipe and 180' of 2" pipe would be necessary to extend the water system at the Cemetery. Motion was made, seconded and carried to authorize the purchase of the necessary tools at the cemetery.

City Treasurer, John Eid read his report for the second quarter of 1940. Motion was made, seconded and carried that the Treasurer's report be accepted, subject to audit of the Finance Committee.

Councilman Koehler reported that the oiling of the various streets would be started in the next few days.

Regular meeting, August 5th. Continued.

Motion was made, seconded and carried that Night Watchman Kendall be allowed his vacation, to start next week, the Committee to arrange for a man to take his place during his absence.

Motion was made, seconded and carried that the Mayor appoint a Budget Committee. Mayor Vinyard then named the following persons to serve on the Budget Committee: George F. Bates, W. Sandsness, George Cattley, E. A. Krueger, John Koehler, Peter Kylo, Craig Dedman and E. C. Shull.

Floyd Hall addressed the Council, submitting a copy of an ad that he expects to have appear in the Fair edition of the Canby Herald, and requested that the Council sponsor and pay the cost of same. This request was rejected by the Council. After some discussion motion was made, seconded and carried that the Council recommend to the Budget Committee to include an item of \$100.00 in the Budget for advertizing purposes.

There being no further business on motion the Council adjourned.
