

The regular monthly meeting of the Council was held Monday February 7th.8 o'clock P.M.On roll call there were present Mayor Vinyard,Chief of Police Rothenberg,Recorder Mangus and Councilmen Cutsforth,Everhart,Koehler,Porter,Rothenberg and Thompson.Councilman Gesik reported later,Attorney Wait and Councilman Pfister absent.

Minutes of the regular January meeting and Special meeting of January 10th.were read and approved.

The following communications were read by the Recorder.A letter from the Volunteer Fire Dept.advising the reelection of Christ Kraft,Jr.to Chief of the Fire Dept.A letter from High School Dist.#4,requesting a reduction in their electric rate.Two offers for the lot on Main St.which was formally occupied by the old City Hall.Renewal of Fire Insurance policy on the building at the City Water Tank.

Mr.A.H.Knight addressed the Council in regard to the straightening out of the road at the head of "C"St.

Mr.White & Mr.Lawton,Representatives of the B.F.Goodrich Co. addressed the Council in regard to the purchase of fire hose.

This matter was left with the Committee for recommendation.

On motion,seconded and carried the above claims were allowed, all bills being voted yea,except bill of Canby Plumbing & Heating Co.for \$72.88 which received negative votes from Councilmen Porter and Thompson.

Mr.Lent reported the water main on the Knight's bridge road had been lowered,also three water lines had been put in across Third St.and that four more were to be put in.He also presented for the Council's consideration an ordinance reducing electric rates and recommended that the new schedule be adopted.

Fire Chief Kraft stated that the hose tower had been completed and that there were no fires during the past month.He recommended that the Council purchase additional fire hose.

After some discussion Mr.Thompson presented a motion,which was duly seconded,that the City purchase 500 ft.of 2 1/2 inch, and 100 ft.of 1 1/2 inch fire hose.On vote of the Council motion carried.

Motion was made and seconded that the selection of hose be left with the Committee,on vote of the Council motion passed.

Mr.Koehler stated that the work on Third St.and Knight's bridge road was about finished.

The Recorder was instructed to renew the fire insurance policy on the pumphouse.

Ordinance #92, fixing the rates to be charged the users of electric light, power and heat furnished by the electric light and power system of Canby, was introduced. On vote of the Council was passed on first reading and ordered published.

On motion, seconded and carried the Recorder was instructed to request the Highway Commission to repaint the safety lanes across the Pacific Highway and to install safety blinkers at intersections. The Recorder was also instructed to ask the Highway Commission to trim the trees along the highway thru town.

Motion was made and seconded that the offer of J.C. Allman for the old City Hall lot be accepted. His offer being \$850.00 for the lot, \$400.00 down and monthly payments of \$15.00 or more per month on the balance. On vote of the Council motion carried.

Mayor Vinyard stated that Ray Fish would like to make the City an offer for the lot that was formally used as a pound. This matter was referred to the Committee for consideration and a report at the next meeting.

City Treasurer John Eid submitted his report for the fourth quarter of 1937. This was referred to the Finance Committee for approval.

Councilman Everhart asked the Council to consider the matter of straightening out the turn at the head of "C" St. After some discussion this was left with the Committee for investigation.

There being no further business, on motion the Council adjourned.
