

Special Meeting.
March 29, 1937.

A Special meeting of the Council was held Friday March 19, 1937 8 o'clock P.M. On roll call there were present Mayor Vinyard, Atty. Wait, Chief of Police Rothenberg, Recorder Mangus and Councilmen Cutsforth, Gesik, Koehler, Pfister, Rothenberg and Thompson. Councilmen Porter and Everhart reported later.

The Mayor stated that the meeting was called to canvas the vote of the recent Special election.

The Recorder then read the statement as certified by the Judges and Clerks of the Election Board, as follows:

The Mayor then read the following Proclamation:

I, J.R. Vinyard, Mayor of the City of Canby, Clackamas County, State of Oregon, do hereby proclaim and declare, that at a Special City Election held in Canby, on Tuesday March 16th. 1937. for the purpose of submitting to the legal voters of Canby, for their adoption or rejection the question; Shall the City Council of Canby, Oregon be authorized and directed to accept the proposal of The Zion Cemetery Association to transfer all it's right title and interest in said Zion Cemetery, together with all it's assets to The City of Canby, upon the promise and agreement of said City of Canby, to take care of and maintain said Zion Cemetery in a good and suitable manner; And whether Canby shall upon taking over said Zion Cemetery exercise the option which Canby now holds to purchase about 16 acres of land adjacent to said Cemetery, to be used for Cemetery purposes.

Submitted to the legal voters of Canby for their adoption or rejection, at a Special City Election held on Tuesday March 16, 1937.

I find that the vote cast at said Special Election was; as follows, to wit: Total number of votes cast-----102


Total number of votes cast in favor of accepting said proposition to take over said Zion Cemetery, and to purchase said land 87

Total number of votes cast against accepting the proposition and to purchase said land,-----15

I, Therefore proclaim and declare, that the taking over of said Zion Cemetery, and the purchase of said 16 acres of land was and is directed and approved by the legal voters of Canby.
