

The regular monthly meeting of the Council was held Monday November 2nd. 8 o'clock P.M. On roll call there were present Mayor Vinyard, Atty. Wait, Chief of Police Rothenberg, Recorder Mangus and Councilmen Bates, Cutsforth, Giger, Hornig, Koehler, Porter, Rothenberg, and Thompson.

Minutes of the last regular meeting were read and approved.

Communications from the State High way Dept., Robison, Scott & Scott, Public Works Administration, Statement of Caucus meeting and two Petitions were read by the Recorder.

On motion, seconded and carried the above claims were allowed.

Fire Chief Larson reported the Department answered one call during the month. No damage.

Mr. Rothenberg stated one of the jail doors would be removed this week to be placed in the new jail and that a temporary door should be installed until the new jail is completed. Mr. Rothenberg was instructed to look after this matter.

Mr. Lent stated material for intersection lights was on hand and that instillation would be made as soon as permission was obtained from the Highway Department.

Neal Thompson then addressed the Council asking that the Rifle Club be given permission to use the second floor of the City Hall as a rifle range. Motion was made seconded and carried that the Rifle Club be allowed to use the City Hall for a rifle range providing the necessary precautions for safety are made.

The Finance Committee approved the Treasurer's report for the third quarter.

Mr. Bates stated the pumphouse roof had been repaired.

Mr. Hornig stated that a street light was removed from a pole across from the High School, leaving an eight inch step in the dark. Mr. Porter, Chairman of the Light Committee, stated that after consideration light was moved about fifty feet and that there is sufficient light there now. Mr. Lent stated that the move had met the approval of the School Board. Mayor Vinyard stated that he would go over and look the matter over.

Ordinance #78 then came up for final action. On motion, seconded and carried was declared passed. Yeas 8, Nays 0.

Ordinance #79 then came up for final action. On motion, seconded and carried was declared passed. Yeas 8, Nays 0.

Motion was made seconded and carried, that funds on hand in the Sidewalk Improvement Account be transferred back to the Water and Light Sinking Fund.

Motion was made and duly seconded, that \$6,500.00 be transferred from the Water & Light Sinking Fund into an account known as the City Hall Construction Account. On vote of the Council motion carried.

Mr. Hornig then addressed the Council stating that the office of Fire Chief is filled by an Alien. Mayor Vinyard referred the matter to Attorney Wait for an opinion. He advised that he did not think that there was anything to prevent an Alien holding an appointive office.

The matter of drainage on Main Street was left in the hands of the Committee.

The Recorder was instructed to get in touch with the Southern Pacific Co. requesting the use of their property as parking space.

Mayor Vinyard brought up the question of changing the east wall of the new City Hall from brick to tile. After due discussion was agreed to leave as originally planned.

Motion was made,seconded and on vote of the Council,passed,that City Treasurer John Eid and Recorder Roy L.Mangus be authorized to handle Construction Account for the new City Hall and that application for Grant of 25% of total be made to the United States Government.

There Being no further business,on motion the Council adjourned.
