M.J.Lee then addressed the Council,stating that he had a party that would like to lease the old wells for irrigation purposes on the Knight property.He was advised to have the parties interestad to make their proposition in writing to the Council.

The Police Committee was instructed to arrange for a night watchman to relieve Mr.Kendall during his vacation.

Ordinance #77 was read by the Recorder,on motion,seconded and carried Ordinance #77 was passed on first reading and ordered published.

The Recorder was instructed to write all delinquent sidewalk accounts requesting an immediate settlement.

There being no further business,on motion the Council adjourned.
