

The regular monthly meeting of the Council was held Monday May 6th. 8 O'Clock P.M. On roll call there were present Mayor Vinyard, Atty Wait, Chief of Police Atwood, Recorder Mangus and Councilmen Bates, Cutsforth, Hornig, Koehler, Porter, and Rothenberg. Councilman Thompson reported later.

The minutes of the previous meeting were read and approved.

Communications were read by the Recorder as follows. State Industrial Accident Commission, in regard to insurance rates on S.E.R.A. project. National Economic Welfare Federation, a protest in regard to the activities of the Chief of Police. League of Oregon Cities, referring to 1935 Legislative Assessment.

On motion, seconded and carried the above claims were allowed. Yeas, 7 Nays, 0.

Mr. Buggins addressed the Council that he had heard a rumor to the effect that outside labor would be used on S.E.R.A. projects in the future. He was assured by the Mayor that if Canby had any more S.E.R.A. work and if the City had anything to say about it, "That local labor would be used."

#### Reports.

Chief of Police reported a pound is needed. After discussion was moved and seconded, that the matter of a pound be left in the hands of the Streets and Public Property Committee. Motion carried as ordered.

Fire Chief Larson reported the new Fire Truck would be here the 15th. and the Volunteer Fire Dept. plans to hold a street parade and dance on the 25th. He gave an inventory of hose on hand and stated that some new hose would be required.

Was moved and seconded that the Fire and Water Committee have a hose dryer built. Motion carried as ordered.

Was moved and seconded that the Fire and Water Committee call for bids on 1 1/2 and 2 1/2 inch fire hose. Motion carried as ordered.

Mr Lent reported that the new transformer was working satisfactory. He stated the new electric line had not been put in service yet. Mr Lent was instructed to post reward signs on the city property. He stated a water rate had been set for the Fair Grounds.

Mr Koehler reported that two streets below the Fair Grounds will need to be graveled before fall.

Motion was made and duly seconded that the Commercial Club be given the privilege of using the Council Chambers as a regular meeting place. Motion carried.

Was moved and seconded that the Legislative Assessment of the League of Oregon Cities be paid. Motion carried.

On motion seconded and carried Council adjourned.
