

The regular monthly meeting of the Council was held Monday June 3rd. 8'0'Clock P.M. On roll call there were present Mayor Vinyard, Atty. Wait, Chief of Police Atwood, Recorder Mangus and Councilmen Bates, Cutsforth, Giger, Hornig, Koehler, Porter, and Rothenberg. Absent Thompson.

The minutes of the previous meeting were read and approved.

Communications were read by the Recorder from the following, Oregon Insurance Rating Bureau, report of test on fire truck. Pennsylvania Salt Mfg. Co., stating contract for liquid chlorine will soon expire and new contract inclosed. Donald C. Bauer, County Auditor, in regard to bills for work done by the County for the City. These were turned over to Mr. Eid to be checked over.

Bids were then opened and read on fire hose. Representatives of eight manufacturers appeared before the Council, submitting samples and going into details about hose.

After due consideration and discussion, motion was made and second that contract be awarded to Eureka Fire Hose Division, of United States Rubber Products, Inc. for 600 ft, 2 1/2 inch fire hose @ \$1.20 per foot, and 100 ft. 1 1/2 inch fire hose @ .80 per foot. Motion carried.

Mr. Koehler reported that he was going to have the grass along the streets cut. Also that sidewalk in front of the Hess property on "C" street is in had need of repair. Motion was made and seconded, that sidewalk in front of the Hess property on "C" street be repaired. motion carried.

Ordinance # 70 was read. Was moved and seconded that ordinance # 70 be passed on first reading and ordered published. Motion Carried.

Ordinance # 71 was then brought up. On motion made and second ordinance # 71 was ordered passed as first reading and ordered published. Motion Carried.

Motion was made and second to pay Howe Fire Apparatus Co. \$3,427.60 for fire truck. Motion Carried.

On motion second and carried the Recorder was instructed to make arrangements with the State Industrial Accident Commission for insurance on the Volunteer Fire Dept.

Mr. Markee then addressed the Council and presented a Resolution requesting the Council to sponser a S.E.R.A. Library project. After discussion, motion was made and second that resolution be left on the table to some future date. Motion carried.

On motion seconded and carried Council adjourned.
