Regular Monthly Meeting Febr. 1-1932

The regular monthly meeting of the Council was held on Monday, Febr. 1, 1932 at the usual hour.

On roll call there were present: Mayor Dedman, Attorney Wait, Chief of Police Lent, Recorder H. B. Evans and Councilmen Bates, Dimick, Graham, Koehler, Patch, Porter and Thompson. Absent Councilman Meeks.

The minutes of the previous meeting were read and approved.

Communications.

The Recorder read a communication from the Secretary of the League of Oregon Cities, announcing a meeting to be held at Eugene on February 26 and 27 and asking that Canby be represented. No action.

A communication from the State Ind. Accident Commission was read, in which attention was called to the fact that the fire department should be protected outside of city limits, that is, in case of help extended to rural districts. Recorder was instructed to ask for rate and attend to having the extra hazard covered.

On motion, seconded and carried, the above claims were allowed.

Reports .

Mr. Wait reported having received permission from Mr. Blaser on behalf of the Canby Rivers Irrigation Co. to change the culvert at the point on the river road where the proposed improvements are to be made.

The Recorder was instructed to sign the agreement for the City, and return copy to Mr. Blazier.

Mr. Dimick reported that as soon as the weather permitted, work would commence on the river road.

Mr. Graham stated for the Finance Committee that the back taxes on the property at B and Second sts. amounted to \$ 325.00and would soon be sold for the taxes. Suggested that later the City might be able to settle for less.

Whereupon Mr. Fred Weygandt being present asked the Council for gravel and grading on the road adjacent to his brother's property on the south side of town, stating that his brother would spend \$25.00 if the City would match it. The Street Supt. was asked to look into the matter.

Whereupon Councilman Koehler stated that the well should, in his

opinion be cleaned this month.
Whereupon City Treasurer Eid stated that he thought it was time to reduce water rates, and Mayor Dedman suggested that the water and Finance Committees confer in the matter, working out a proposed schedule.

Fire Chief Larson asked the Council for additional equipment, such as water proof coat and boots. Also some roof ladders. Left to Committee.

Mr. Lent asked for floor covering for City office. Also left to Com.

Whereupon the matter of the nightwatchman coming up, on motion, seconded and carried it was voted that he be paid by the City, the sum of \$ 75.00 per month, and that there be no private protection.

The following Ordinance was then introduced, and on motion, seconded and carried, passed on its first reading and to come up for final action, on March 7, after being legally publixhed in the Canby Herald.

Health regarding the appointment of a health officer. This matter was turned over to the City Attorney for consideration as to requirements in regard to same.

Reports.

Mr. Lent reported electric line change at the Wait property and hydrant

Fire Chief Larson reported having received letter of thanks from the Aurora Fire Department for making the run to Aurora at the time of the Yoder fire.

Mr. Koehler for the Light and Water Committee reported the well having

been cleaned and the flow of water now satisfactory.

Mr. Dimick reported work done on the river road and Cemetery road, and some dragging on the Weygandt road. Also suggested and recommended that some improvement should be made, in connection with the County, on road running from the S.P. tracks in to and adjacent to the Kronberg property.

The Council was favorable to the suggestion and he was told to go ahead.

City Treasurer Eid recommended that in order to replenish the Road Fund, two warrants of \$ 300 each be drawn in favor of the Water and Light Sinking Fund, registered for interest and the money be deposited in the Road Fund. So ordered.
