

The regular monthly meeting of the Council was held on Monday, August 1, 1932 at the usual hour.

On roll call there were present: Mayor Dedman, Attorney Wait, Chief of Police Lent, Recorder H.B. Evans, and Councilmen Bates, Dimick, Graham, Koehler Meeks, Patch, Porter and Thompson.

The minutes of the previous meeting and those of the Special meeting of July 11 were read and approved.

Communications.

The Recorder read a communication from the State Ind. Accident Commission rejecting the Erle Bowsby claim for compensation.

Whereupon, on motion, seconded and carried the City Attorney was asked to write the Commission, objecting strongly to their stand in the matter.

A letter from Mrs. Ripley, addressed to the Red Cross Society and turned over to the Recorder and asking for free water service was also read.

Request was not granted, and Mr. Koehler was asked to see her and explain.

Also a communication from Bureau of Labor asking for a blueprint of the water system for statistical purposes. Referred to Messrs. Lent, Eid and Evans.

Also another letter from the State Ind. Acc. Com. regarding outside fire calls and requesting more information about organization. Recorder instructed to furnish same.

Also communication from Fire Chiefs Association regarding storage of gasoline. No action.
