Street Committee and Superintendent requested to investigate the advisability of cutting grass along the various streets.

Mr. H. E. Browne reported the usual mess in the vicinity of the Stefani lumber yard, and the Street Committee was instructed to look after same.

Fire Chief Larson reported having made a run to fire at New Era.

The City Recorder was instructed to prepare and acceptance to be signed by the Canby Rivers Irrigation Company in the matter of their franchise.

On motion, seconded and carried, it was voted to allow a change in the laying of the pipe line of the above Company, by granting them the privilege of using "E" street, subject to the approval and under the direction of the Committee on Streets and Public Property.

There being no other business on motion, seconded and carried, The Council adjourned.

Whereupon several citizens being present and desiring to be heard in regard to the irrigation ditches being excavated by the Canby Rivers Irrigation Co., the Mayor invited them to speak.

Rev. T.H.Downs voiced his objections to an open ditch adjacent to the Methodist Church. Also Mrs. H.N.Brown, Frank Zollner and Mrs. Bertha McFarland by Aug. Rothenberg raised objections.

M.J.Lee for the Company spoke at some length, asking for a square deal, and stating that the work was incomplected, and that while the work was going on, it was necessary to mar the landscape and inconvenience people more or less.

Mayor Dedman assured the objectors that the matter would be worked out by the Council in a manner satisfactory to all.
