

June 4-1928

The City Council met in regular session on Monday, June 4, 1928 at 8 o'clock P.M.

On roll call there were present: Mayor Bair, Attorney Wait, Chief of Police Lent, Recorder H.B.Evans, and Councilmen Graham, Koehler, Patch, White and Zimmerman. Councilman Shewey reported later and Messrs. Dedman and Garrett were absent.

The records of the previous regular meeting of May 7, and those of special meetings on May 23 and 29 were read and approved.

The Mayor announced that the usual order of business would be interrupted and Mr. Ellis, President of the Greater Clackamas Union of Clubs desired to address the Council.

Mr. Ellis stated that through his efforts, a tract of land on the opposite side of the Molalla River near the Knight Bridge had been chosen for a permanent " Camp Grounds " by the Christian Missionary Alliance, and that in his opinion this would result in great good for Canby, as at certain times there would be large numbers attending meetings who would naturally pass through and do more or less business in the City.

He therefore urged the improvement of the road leading to the bridge, the widening and grading of the hill, the extension of electric power through the bridge and special rates for same if possible.

Mr. Ellis was assured by the Mayor that the Council would be favorable towards doing everything in their power in the matter, with the limited funds available.

#### Communications.

A communication from Foster and Kleiser was read, in which they asked permission to erect a sign board on property leased from G.K.Bair, about 200 feet south of "C" street on the Pacific Highway.

On motion of White seconded by Graham and carried, the request was granted.

Whereupon the Recorder read a communication from I.D.Taylor stating that he had formulated a statement of the amount of refund of road taxes due Canby from the County, covering the years 1919 to 1924 inc.

He figured the amount to be \$ 3495.64, and according to settlements with other towns in the County on a basis of 28%, there would be due from the County the sum of \$ 978.80.

## Reports

The Committee on Fire and Water reported having the matter of mossy roofs still in mind.

The Street Committee reported no money to work with.

Supt. Lent reported wells repaired, work finished and all in good shape.

Mayor Bair asked the Street Committee to investigate the approach to Knight's Bridge with the idea of widening it in accordance with the request of Mr. Ellis.

On motion of Graham, seconded by White and carried, it was voted to install not more than five lights on the Bridge and hill during the camp meeting session.

Whereupon the following Resolution was introduced by Graham:

RESOLUTION OF INTENTION TO IMPROVE CERTAIN STREETS  
BY HAVING CEMENT SIDEWALKS BUILT THEREON.

Whereas, the City Council of Canby deems it expedient and necessary to improve the hereinafter named streets, in the City of Canby by having sidewalks built along the property abutting on said streets, as hereinafter set forth; and Whereas the City Council of Canby, deems it expedient and necessary to make and create an Improvement District of the streets so to be improved;

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF CANBY, that it is hereby declared to be its intention to create an Improvement District to improve by laying sidewalks therein, on the following named streets, and on that part of them as hereinafter set forth.

"B" Street from First street to Sixth street, by laying six foot cement sidewalks on both the East and West sides of the street.

"C" Street by laying eight foot cement sidewalks from First street to Fourth street and six foot cement sidewalks from Fourth street to Sixth Street, on both the East and West sides of the street.

Second Street by laying four foot cement sidewalks on both the North and the South sides of the street.

Third Street by laying four foot cement sidewalks on both the North and South sides of the street.

Fourth Street by laying four foot cement sidewalks on the North side of the street between "B" and "C" Streets.

Fifth Street by laying four foot cement sidewalks on the North side of the street between "B" and "C" Streets.

BE IT FURTHER RESOLVED, that this Resolution of the Council declaring its intention to improve the aforesaid Streets by laying sidewalks thereon shall be kept of record in the office of the City Recorder, and shall be published for two weeks in the Canby Herald a newspaper of general circulation published weekly at Canby, Oregon, and by posting three copies thereof, in three public places in said City of Canby, at least fifteen days before the time set herein, to wit; the twenty-seventh day of June, 1928, as the last day on which a Remonstrance against said proposed Improvement may be filed, and;

BE IT FURTHER RESOLVED, that fifteen days after the publication and posting of this Resolution, the resident owners, or their agents, representing property abutting upon said streets, or part thereof, proposed to be improved by the construction of sidewalks by the owners of the said property, may make and file with the City Recorder a written remonstrance against the proposed Improvement, ("Owner as herein used shall be construed to mean the legal title holder, and abutting property shall be construed to mean between the street and center of the Block, in blocks having an alley parallel with the street, "Abutting" shall mean to the line of the Alley nearest the street) which said Remonstrance will be considered by the Council at its next regular meeting after the expiration of said fifteen day period.

The motion by Graham, seconded by Shewey, carried and the above resolution was adopted.
