

A special meeting of the City Council was held on Thursday, Jan. 20 1927 at 8 o'clock, P.M.

On rollcall there were present: Mayor Bair, Chief of Police Lent, Recorder H.B. Evans and Councilmen Bowlsby-Dedman-Garrett-~~Graham~~ Patch-Shewey-White and Zimmerman. Absent, Atty Wait and Councilman Graham.

The Mayor announced that the meeting was called for the purpose of discussing matters pertaining to the new Union High School grounds, the streets leading thereto, etc.

Mayor Bair after making extended remarks with reference to the above, called on the Committee from the Chamber of Commerce who were present.

Mr. Ellis, speaking for the Committee, stated that they favored erecting the new school building considerably to the North of the location contemplated, and that he and Mayor Bair had secured options on more land lying to the west of the north end of the school property, with the idea of buying and deeding to the District, should it be deemed advisable.

Mr. Elmer Gribble, Mr. Belton and Mr. Markee also spoke as members of the Committee, and along the same lines.

After a general discussion, Mayor Bair announced that the accepting or rejecting the offer of the School Board to ~~deed~~ add a strip of land to the City to be dedicated as a street would be in order.

Councilman White suggested that rather than take action at this time, it might be well to meet with the School Board and citizens and discuss the advisability of securing more land with the idea of requesting the Board to consider the matter of re-locating the site of the proposed school more to the north.

On motion of Shewey, seconded by White and carried, it was voted to ask the School Board of Union High School District #1, and representatives from the Canby Chamber of Commerce to meet with the Council at 7.30 P.M. Friday, January 21.

Adjourned, Special Meeting
Friday, January 21-1927

The Council met in special session adjourned from Thursday, Jan. 20. Present: Mayor Bair, City Atty. Wait, Chief of Police Lent, Recorder H.B. Evans and Councilmen Bowlsby, Dedman, Garrett, Graham, Patch, Shewey White and Zimmerman.

With reference to the matter discussed in the previous meeting, the Mayor stated that he and Councilman Dedman had had a conference with Mr. Cole of the School Board, who said that the Board would consider a proposition to deed the District more land and to change the location of the school as previously planned.

Mayor Bair also suggested that possibly a petition for a referendum vote on the location of the school might be necessary and advisable.

Councilman Dedman confirmed Mayor Bair's remarks as above mentioned, and introduced the following Resolution, which seconded by Graham and carried was declared adopted:

Resolution adopted by the City Council of Canby
at a Special Meeting, January 21-1927

WHEREAS:

We, the members of the City Council of Canby, believing it to be for the best interests of both the Union High School District No. 1, and the City of Canby, that the proposed new school building be located and built on the North end of the tract owned by the said District, now therefore, BE IT RESOLVED, That, we the City Council of Canby, in the event that said Union High School District No. 1 shall decide to locate said building on the North end of said tract, do hereby agree to secure and deed to said Union High School District, two acres of land, or as much of the two acres as the School Board may deem necessary, off the land lying adjacent to the northeasterly portion of the property now owned by said Union High School District, the same being the property of Bertie Nelson and

M. Francis Nelson, her husband-providing however that the proposed new high school building shall be erected on the northerly portion of the Union High School property and this property which the City Council proposes to purchase and deed.

Respectfully submitted to the Board of Directors of Union High School District No. 1, Clackamas County, Oregon, for their early consideration. Passed by the City Council of Canby, Oregon, Jan. 21-1927.

The Recorder was instructed to present the above Resolution to the School Board of Union High School District No. 1 as soon as possible.

Whereupon, Mr. Ellis on behalf of the Canby Chamber of Commerce extended their thanks for the consideration given their petition by the Council.

Whereupon Mr. Eid suggested that should it be found necessary to purchase the extra land as above mentioned, it might not yet be too late to make a special levy and get it on the next tax roll.

There being no further business on motion, seconded and carried, the meeting adjourned.

Special Meeting.

Tuesday-January 25-1927.

A special meeting of the City Council was called on Thursday, Jan. 25-1927 at 8 o'clock P.M.

Present* Mayor Bair, Atty. Wait, Chief of Police Lent, Recorder H.B. Evans and Councilmen Bowlsby, Graham, Patch, Shewey, White and Zimmerman.

The Mayor announced that the meeting was called for the purpose of meeting with the Directors of Union High School District #1 to discuss the advisability of purchasing additional land adjoining that already owned by the District, with the idea of having the proposed new school buildings located further to the north and closer to the State Highway, rather than on the location as planned by the School Board.

It was announced that certain options for additional land had been secured from Bertie W. Nelson and M. Francis Nelson and from W. L. Barker and Anna Barker.

Whereupon the Mayor stated that in case additional land should be deeded to the School District, it might be possible to secure from the District an equal acreage from the property already owned.

Whereupon Mr. Cole of the Board of Directors of Union High School District #1 presented the following:

RE: LOCATION OF PROPOSED NEW HIGH SCHOOL BUILDINGS.

" The Board of Directors of Union High School District No.1 deem it essential. in order that they may consider the matter intelligently and place the matter before the voters of the District if deemed necessary, that they have in their possession the following:

First;

An option on the property lying between the Northeastern portion of the School property and the Railroad property to the West thereof; a property known as the Nelson property, containing about three acres more or less. The above option together with tangible assurance that the property will be presented to the Union High School District, free of incumbrance and with warranty deed and complete abstract.

It is deemed to be to the best interests of all that the above be in the hands of the Union High School Board not later than 6 P.M. on Thursday, January 27-1927.
