The regular monthly meeting of the City Council was held on Monday, February 7-1927 at 8 o'clock P.M.

On roll call there were present: Mayor Bair, Atty. Wait, Chief of Police Lent, Recorder H.B. Evans and Councilmen Garrett, Graham, Patch, Shewey, White and Zimmerman. Councilmen Dedman came in later, and Councilman Bowlsby was absent.

The Mayor announced that a committee from the Civic Club was present and wished to be heard, and if there was no objection, the order of business would be reversed in order that the ladies might depart early if they

Mrs. E. Bowlsby, speaking for the Club stated that the Club desired to rename the streets and number the houses, as there seemed to be quite a demand for such action.

On motion of White seconded by Shewey and carried, it was voted to grant

permission subject to ratification by Ordinance.

Whereupon, Mrs. Shewey, for the Civic Club asked the cooperation of the Guncil in cleaning up the City, and asked for use of a truck between the 10th and 15th of the present month. Granted.

Reports.

The Street Committee reported that considerable work on the streets was necessary, but failed to state whether or not it would be done.

Mr. Lent reported that the Thompson transformer had been installed, and was giving satisfaction. Also that the volmeter records recently had been satisfactory, but when first installed had shown a very unsatisfactory ondition.

Mr. Lent also answering criticism in the paper regarding the sanitary condition of the jail, stated that it was impossible to keep it in proper condition unless it was kept closed and locked, and that the roof required repairs.

Mr. Rothenberg reported many rotten limbs in a dangerous condition in

trees along Front street. Referred to Street Committee.

WHEREAS The directors of Union High School District No. 1, of Clackamas County, Oregon, had determined to build and erect the High School

said tract of land as requested by the citizens of Canby, if and provided the
City of Canby will purchase the following described real property owned by
Bertie Nelson and M. Francis Nelson and adjacent to and lying along the west
line of the tract of land belonging to the Union High School District #1,
Clackemas County, Oregon, and after they have purchased the said tract of
land will convey it by deed to said Union High School District #1,
for their
full use and benefit;

being more particularly described as follows, to-wit:

Beginning at the Southeast corner of the L.A.Seeley D.L.C. in Section four (4), Twp. four (4), S. of Range 1 East of the W.M., running thence south 5.40 chains; thence east 5 chains; thence north 12.60 chains to the south boundary of the Philander Lee D.L.C.; thence south 78° 15' west, 5.45 chains to the east boundary of the said Seeley D.L.C.; thence south 6 chains to the place of beginning, excepting therefrom the south 5.40 chains thereof,

being about 31 acres.

NOW THEREBORE BE IT RESOLVED by the City Council of Canby, Clackamas County Oregon; That the City of Canby does agree to and with the said Board of Directors of Union High School District #1 of Clackamas County, Oregon, that the City of Canby, in consideration of the promise of said Board of Directors heretofore made to locate and build said High School building upon the North end of the aforesaid tract of land, will purchase the aforesaid $3\frac{1}{2}$ acres of land lying west and along side of the tract of land owned by the said Union High School District, and upon the purchase thereof will convey it by deed to said Union High School District #1, and in furtherance thereof will introduce an Ordinance calling for a special election of the legal voters of the City of Canby, for the purpose of submitting to them the question of levying a special tax for the purchase of said $3\frac{1}{2}$ acres of land, and conveying it to said Union High School District #1 as aforesaid.

Whereupon the following Ordinance was introduced: ORDINANCE NO (217)

An Ordinance providing for the holding of a special election, for the purpose of submitting to the legal voters of Canby, Clackamas County, Oregon, for their adoption or rejection, the question of authorizing and empowering Canby to raise by taxation the sum of three thousand three hundred dollars for the purchase of three and one half acres of land adjoining the tract of land owned by Union High School District #1, of Clackamas County, Oregon, and deeding said tract of land so purchased to said Union High School District for school purposes and declaring an emergency.

CANBY DOES ORDAIN AS FOLLOWS:

SECTION 1- That there shall be held in Canby, Clackamas County, Oregon on Saturday, March 19, 1927, a special election for the purpose of submitting to a vote of the legal voters of Canby, for their adoption or rejection, an act authorizing and empowering Canby to raise by a special tax for that purpose, the sum of three thousand three hundred dollars, three thousand dollars to be paid to Bertie Nelson and M. Francis Nelson for three and one half acres of land lying on the west line of the tract of land owned by Union High School District #1 of Clackamas County, Oregon, and three hundred dollars to be used as interest on warrants if necessary to issue same in payment of said tract of land; and that upon the purchase of said 32 acres of land it shall be deeded by Canby to said Union High School District for its full use and benefit, upon the express condition and agreement that the Board of Directors of said Union High School District shall build and erect the High School building of said District upon the North end of the aforesaid tract of land owned by said Union High School District adjoining the said 32 acre tract of land, as provided in Resolution of this City Council heretofore passed.

SECTION 2- The Recorder of Canby is hereby authorized and directed to post in six conspicuous places within the corporate limits of Canby for at least ten days prior to Saturday, March 19-1927 notices of the special city election to be held in Canby on said date, to-wit; Saturday, March 19, 1927, which said notice of election shall state the date upon which said election shall be held and shall designate the purpose of said election, the polling place thereof and the hours that the said polls shall be opened and shall name the judges and clerks of the said election and give the ballot title

of the proposed act to be submitted to a vote of the electors of Canby, for their adoption or rejection at said special city election.

SECTION 3- The Council of Canby shall hereafter by motion appoint judges and clerks of said special election; that said judges and clerks shall receive as full compensation for their services as such the sum of three dollars per day each.

SECTION 4- The election ward or precinct for said special city election shall be and constitute all of the territory included within the corporate

limits of Canby.

SECTION 5- There shall be one polling place for said special city election, to-wit; in the Council Chamber of the City Hall.

SECTION 6- Whereas it is necessary in order to have the District High School building erected in the location desired by the citizens of Canby, that this Ordinance become operative at once, therefore in order to preserve the best interests and peace of Canby, and it's catizens, an emergency is hereby declared and this Ordinance shall become immediately operative and in full force and effect upon it's passage by the Council and approval by the Mayor.

Read for the first time at a meeting of the City Council held on Febr. 7-1927 and ordered posted for the reason that, in the opinion of the Council, the cost of publication thereof is excessive, and to come up for final action at the regular meeting of the Council to be held on March 7-1927.

Whereupon a petition signed by various citizens was presented, asking the City Council to take some action toward securing better electric power.

On motion of Shewey, seconded by Garrett and carried, the Recorder was instructed to ask the Public Service Commission to hold a hearing in Canby and to listen to complaints regarding the electric power service.
