Whereupon Mr. Lent reported two very bad fire hazards, and the Committeee on Fire and Water was instructed by the Mayor to look after the matter, and also remove or have removed moss on various buildings where it seemed advisable.

Mayor Bair also recommended that those constituting the volunteer Fire Department, get together occasionally for practice.

Meters.

The matter of deciding on the kind of meters to be bought

in accordance with the recent Ordinance passed being next in order, the several meter salesmen present were invited to show their stuff."

After the various demonstrations, on motion of Councilman Graham, seconded by White and carried, it was voted that the bid of the Hershey Company be accepted, and that seventy five straight reading meters be ordered at once at a price of \$ 11.82 each.

Whereupon Councilman Dedman suggested and advised that at A and E street intersection with the Pacific Highway, stop signs should be placed, and this matter was left to the Committee on Streets and Public Property with power to act.

Special Meeting, June 14-1926

A special meeting of the City Council was held on Monday, June 14-1926 at 7.30 P.M.

On roll call there were present, Mayor Bair, City Atty Wait, Chief of Police Lent, Recorder H.B. Evans, and Councilmen Bowlsby, Dedman, Patch, Shewey, Swanby, Wang and White. Absent Graham.

The Mayor announced that the meeting was called for the purpose of introducing an Ordinance making it compulsory for all users of City water to install meters.

Whereupon the following Ordiance was read: (211)

ORDINANCE NO

An Ordinance making it compulsory for every person who uses or wishes to use water furnished by the Water Department of the City of Canby, Oregon, to apply for and procure a water meter from the City and have it installed by the Superintendent of the Water Department of Canby.

CANBY DOES ORDAIN AS FOLLOWS:

SECTION 1-Every person who is using or who hereafter desires to use water from the Water Department of Canby, Oregon, shall within ten days from the final passage of this Ordinance, and it's approval by the Mayor, make application to the Superintendent of the Water Department of Canby, to have a meter installed on his water pipes, and at the time of the application for a meter shall pay to the said Superintendent of the Water Department, the cost price of said meter and the cost of installment of same.

SECTION 2- The price paid for said meters, and the cost for installing the same, paid to the City by the applicant thereof, shall be repaid to said applicant by the City remitting fifty per cent of the water bill of said applicant each month for two years, unless full re-payment shall have beem made for said meters before that time, as provided by Ordinance of amended Canby heretofore enacted.

SECTION 3- Any person using water from the Water Department of Canby, without or before making such application for a meter and paying for the same, as in this Ordinance provided, shall have the water turnedoff from his or her premises, and it shall not again be turned on, until the provisions of the Ordinance are complied with, and the eastablished fee for turning on the water, paid.

WHEREAS, this Ordinance is necessary for the preservation of the water and the public peace, health and safety of the people of Canby, Oregon, an emergency is hereby declared, and this Ordinance shall go into full force and effect, from and after it's passage by the Council and it's approval by the Mayor.

On motion duly made, seconded and carried, said reading was considered the first reading of said Ordinance, and for the reason that charges for publication thereof were, in the opinion of the Council, excessive, publication was ordered dispensed with, and the Recorder was instructed to post said Ordinance in three public and conspicuous places in Canby for a period of two calendar weeks.

Said Ordinance to come up for final action at the regular meeting

of the Council to be held on Tuesday, July 6-1926.

Whereupon the following Resolution was introduced by Mr. Wang:

WHEREAS, IT creates a hardship for some of the people applying for the installation of water meters to pay the full charge due for the purchase price and installation of their meters, at the time they make application therefor, as provided in the Ordinance of Canby governing the use and installation of water meters. allation of water meters; now

THEREFORE BE IT RESOLVED; by the City Council of Canby, that in those cases in which it shall cause a hardship to pay for the same, as provided in the aforesaid Ordinance, the City will furnish and install the meters

upon the following conditions and terms, to-wit;

The applicant to pay the sum of \$ 5.00 upon filing the application for the meter, and \$ 5.00 after the meter has been installed and in use thirty days, the balance due, when the meter has been installed and in use for sixty days.

On motion, seconded and carried the above Resolution was adppted.

Whereupon the following Resolution was introduced by Mr. Shewey:

WHEREAS, It is the custom in other cities to require a deposit from renters sufficient to cover one month's water service, now therefore, BE IT RESOLVED, that the Superintemdent of the Water System be instructed to collect in advance from such renters, a deposite of \$ 3.00, the same amount to be refunded when service is no longer required and water bill paid in full.

On motion, seconded and carried, the above Resolution was

adopted.

Whereupon it was moved and seconded that the Council adjourn. Motion carried. Sto Evany
