

Regular Monthly Meeting, Aug. 2-1926

The Council met in regular session, Monday, August 2-1926 at eight o'clock, P.M.

On roll call there were present; City Attorney Wait, Chief of Police Lent, Recorder, H.B. Evans, and Councilmen, Bowlsby, Dedman, Graham, Shewey, Swanby and White. Absent: Mayor Bair, Councilmen Patch and Wang.

The meeting was called to order by the Recorder and on motion, seconded and carried, Councilman Dedman was elected Chairman to preside in absence of the Mayor and the President of the Council.

The records of the previous meeting of July 6th. were read and approved.

Reports of Officers.

Mr. Lent reported that 171 meters had been installed, being all the residences and some of the business houses.

He also bro't up the matter of meters for the Masonic Hall, and it was decided that to avoid great expense for the Lodge, that one meter only for the second story should be installed.

Mr. Lent also asked the Council for instructions in regard to customers on the Wm. Knight line, but no action was taken.

The matter of installing a larger pipe into the Fair Grounds from the Snyder corner was also mentioned, and the Recorder stated that the Fair Association had urged that the City share an equal portion of the expense if the Council should see fit to do so.

Mr. Rothenberg reported that stop signs were in place.
