The City Council met in adjourned session on Thursday, Nov. 4-1926 at 8 o'clock P.M.

Thereupon the Mayor declared the above duly elected to serve according to the terms set off against their names as read.

Whereupon the matter of the proposed street leading to the new High School site was brought up, and on advice of the City Attorney, the following Resolution was introduced:

RESOLUTION OF INTENTION.

WHEREAS, The Council of the City of Canby, Oregon, deems it expedient and necessary to lay out and open a public street from a beginning point on the west side of the Canby and Marquam Market Road in Canby, Oregon, and running in a souther westerly direction to terminate and connect with the Pacific Highway at a point near the Southwestern corner of the property belonging to the A.L. Snell Estate in Canby, Oregon, and between it's beginning point and it's terminal point passing through and over the following owned xxx real property, to-wit: property owned by Mrs. Anna Summerfield, Mrs. Sophia Knutson Sandsness, R. E. Karr, Elizabeth White, Edward Krueger, C. P. Shewey, W. A. Lathrop, Agnes Noble, The Estate of W. R. Porter, deceased, Anna Schmitt, Chas. Moore, Arther Knight, Martha Knight, the Estate of A.L. Snell, deceased, Union High School District #1 and Mrs. Bertha Nelson, according to the plat of the Surveyor heretofore appointed by the City Council, and in accordance with the recommendation of the Committee heretofore appointed by the City Council to report on the matter, to enable the public and school children to reach the grounds and building proposed to be erected by High School District Number One, Clackamas Gunty, Oregon, and located and being within the City limits of the City of Canby, Oregon, and WHEREAS; IT has heretofore required from the Surveyor a plat of the

route and location of said proposed street and a decsription of the various lots and parcels of property through which the said proposed street

would pass, and
WHEREAS, THE said Surveyor has heretofore filed such plat and specifications as to the property to be affected by such proposed street, in

the office of the City Recorder, and

WHEREAS, THE Council has examined said plat and received the report of the Committee appointed by the Guncil to investigate the route of said street as planned in said plat, and recommended for adoption by said Committee and the said plat and route of said street and the recommendation of said Committee being satisfactory; now therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CTY OF CANBY, that it is hereby declared to be it's intention to lay out and open a street from a beginning point on the west side of the Canby and Marquam Market Road in Canby, Oregon and running in a southwesterly direction to terminate and connect with the Pacific Highway at a point near the Southwestern corner of the with the Pacific Highway at a point near the Southwestern corner of the property belonging to the A.L.Snell Estate in Canby, Oregon, and between it's beginning point and it's terminal point passing through and over the following owned real property, to-wit: property owned by Mrs. Anna Summerfield, Mrs. Sophia Knutson Sandsness, R.E.Karr, J.K.Hart, Elizabeth White, Edward Krueger, C.P.Shewey, W.A.Lathrop, Agnes Noble, The Estate of W.R. Porter, deceased, Anna Schmitt, Chas Moore, Arther Knight, Martha Knight, The Estate of A.L.Snell, deceased, Union High School District Number One and Mrs. Bertha Nelson, as platted and described in the Surveyor's report and plat heretofore filed with the City Recorder, and,

BE IT FURTHER RESOLVED, that the Surveyor's plat and specifications as to the route pursued and the property to be affected by the laying out and opening of said Street are hereby declared to be satisfactory, and

and opening of said Street are hereby declared to be satisfactory, and are hereby approved and adopted, which said plat and specifications are on file in the office of the City Recorder and there subject to inspection,

and,

BE IT FURTHER RESOLVED, that this Resolution of the Council, declaring it's purpose to lay out and open said street hereinbefore described, shall be kept on record in the office of the City Recorder, and shall be published by posting three copies thereof, in three public places in said City, at least fifteen days before the time set herein, to-wit, the 23rd.

day of November, 1926, as the last day in which a remonstrance against the laying out and opening of said street aforesaid may be filed, and,

BE IT FURTHER RESOLVED, that within fifteen days after the posting of this Resolution, the resident owners or their agents representing property through which the proposed Street will be laid out and opened, may make and file with the City Recorder, a written remonstrance against the laying out and opening of said Street through their property as aforesaid, (Owner as herein used shall be construed to mean the legal title holder), which said remonstrance will be considered by the Council at a Special Meeting to be called Nov. 23-1926.
