Special Meeting, May 10-1926

A special meeting of the City Council was held on Monday, May 10, 1926 at 8 o'clock P. M.

Mayor Bair called the meeting to order and announced that the meeting was called for the purpose of introducing meter ordinance and such other business as might appear.

On roll call there were present: Mayor Bair, City Attorney Wait, Chief of Police Lent, Recorder H.B. Evans, and Councilmen Bowlsby, Patch, Shewey, Swanby, Wang and White. Absent Dedman and Graham.

On recommendation of Mayor Bair, it was moved, seconded and carried that the Recorder be instructed to advertise for bids on meters, in lots of two hundred and fifty or less, bids to be presented and opened on May 27th., at a special meeting of the Council.

Whereupon it was moved, seconded and carried that the Water Committee in conjunction with the Mayor be empowered to purchase 100 boxes for meters.

Whereupon it was moved, seconded and carried that the matter of renewing Electric Light poles in the north end of the City be left to the Committee with power to act.

The following Ordinance was then introduced:

ORDINANCE NO. 1

An Ordinance making it compulsory for every person who wishes to use water for sprinkling purposes in Canby, to procure a water meter from the City and have it installed by the Superintendent of the Water System of Canby.

## CANBY DOES ORDAIN AS FOLLOWS:

SECTIONI- Every person in Canby who has taken out a sprinkling permit for the year 1926, and paid the sum of \$5.00 for the same, shall on or before the first day of June, 1926 make application to the Superintendent of the Water System of Canby to have a water meter installed on his water pipe, and the \$5.00 already paid for sprinkling permit for the year 1926, shall be credited as a part payment of the cost of said meter and the installing thereof, and at the time of the application so made shall pay to said Superintendent of the Water System, the balance of the cost price of said meter and the installing thereof.

SECTION 2-When any person in Canby, other than those mentioned in Section 1 of this Ordinance desires to use water for sprinkling purposes, he shall first make application to the Superintendent of the Water System of Canby to have a water meter installed on his pipes, and at the time of making said application for a meter shall pay to said Water Superintendent the cost price of said meter and the cost of installing the same.

SECTION 3 - The price paid for said meters and the cost for installing the same shall be repaid to the user by remitting fifty per cent of his water bill each month for two years, unless full repayment for said meters shall have been made before that time, as provided by Ordinance of Canby heretofore made and enacted.

SECTION 4 - Any person using water for sprinkling purposes, without or before making such application for a meter and paying for the same as in this Ordinance provided, shall have the water shut off from his premises and it shall not be turned on again until the provisions of this Ordinance are complied with, and the established fee for turning on the water, paid.

WHEREAS This Ordinance is necessary for the preservation of the water and the public peace, health and safety of the people of Canby, Oregon, an emergency is hereby declared, and this Ordinance shall go into full force and effect, from and after it's passage by the Council and

it's approval by the Mayor.

On motion duly made, seconded and carried, said reading was considered the first reading of said Ordinance, and for the reason that charges for publication thereof were, in the opinion of the Council, excessive, publication was ordered dispensed with, and the Recomer was instructed to post said Ordinance in three public and conspicuous places in Canby for a period of two calendar weeks.

Said Ordinance to come up for final action at a special meet-

ing of the Council to be held on May 27-1926.

Whereupon the following Resolution was introduced, and on motion, seconded and carried was ordered spread on the minutes:

TO:

The Oregon State Highway Commission, and to the attention of Mr. Roy A. Klein State Highway Engineer.

We, the officers and members of the Chamber of Commerce of Canby, Oregon, do approve the present existing main thoroughfare thro! this State, running North and South and connecting with the States of Washington and California, as the official Pacific Highway.

We are opposed to any change in said existing thoroughfare save for it's improvement, and we are especially opposed to such change as is planned in which the West Side Highway shall receive the name of the West Side Facific Highway.
