Whereupon the Committee on Fire & Water was instructed to go ahead and build fire truck.

Ordinance for purpose of purchasing Ford Chasis was read, as follows:

ORDINANCE NO 143

An Ordinance to provide for the purchase of a Ford Chasis from the G. W. White Motor Company for a Fire Truck and declaring an emergency.

Section 1. It is hereby declared to be the purpose of the City of Canby to build a fire truck adequate for all emergencies.

Section 2. The recorder and the mayor of the City of Canby are hereby delegated to pay in the usual manner for the Ford Chasis in the amount of \$432.00.

Section 3. In so much as there is an urgent need of a motor drawn fire apparatus and is necessary for the peace, quiet and health of said city, and emergency is hereby declared to exist and this Ordinance shall go into immediate force and effect upon its adoption and approval.

Whereupon it was moved and seconded that the Ordinance be placed on file and posted. Motion carried.

Whereupon the City marshal was instructed to renew the ringing of the curfew and to round up all dogs according to our ordinances.
