RESOLUTION.

Whereas, Canby has heretofore adopted and amendment to the Charter of Canby providing for the purchase or construction of the Electric Light System of Canby, and,

Whereas Canby has negotiated with the Molalla Electric Company who has agreed to sell their distributing system within Canby and offer to deliver on November 2, 1922, a written agreement setting out the terms and conditions of the sale of all property owned by the Molalla Electric Company in Canby for the agreed price of \$7000.00, now then therefore,

It is hereby resolved by Canby that Canby shall purchase from the Molalla Electric Company the flectric Distributing system and all the property owned by the Molalla Electric Company within Canby as described in the Bebe Report and additions thereto since that time. That upon the delivery of a merchantible title free and clear from all incumbrances to the said property by the Molalla Electric Company to Canby, Canby shall pay for such property the sum of \$7000.00 that the Molalla Electric Company shall deliver at such time such assurances as may be necessary and to the satisfaction of Canby showing said title to be merchantible, such agreement shall state that the premises shall be taken as of the last meter reading, together with such further conditions as may be provided for in a written agreement to be signed by the Molalla Electric Company on November 2, 1922, which negotiations shall be made by the flectric Light Committee of the Council of Canby and the City Attorney.

Whereupon the agreement drawn up by the Canby and Molalla Electric Company was read and was as follows:

Memo Agreement.

This agreement contains the details of the sale of the property of the Molalla Electric ompany within the Citylimits of Canby to Canby.

The consideration to be paid the Molalla Electric Company for all of said property shall amount to \$7000.00, which sum includes the street lighting system valued at \$600.00, subtracted from original consideration.

The property to be transferred is all of the property owned by the Molalla Electric Company within the City limits of Canby, as of November 2, 1922, a detailed list of which is contained in the report of Beebe to Canby and the Molalla Electric Company, together with such additions made since that time, and all property of a like nature of the sellers within Canby.
