Whereupon the following Resolution was read:

WHEREAS, it is necessary that a Special City.

Election be held in Canby to submit to the legal voters an amendment by addition to the Charter of Canby, and which Election has been called for February 21, 1922; and

Whereas, it is necessary to designate the judges and clerks for such election and fix their compensation, and to provide a polling place and declare an emergency:

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF CANBY, That the Special Election which shall be held in Canby on February 21, 1922, for the purpose of submitting to a vote of the legal voters of Canby for their adoption or rejection an amendment by addition to the Charter of Canby, providing for a municipal electric transmission and distributing system, and for the purpose of issuing bonds:

The Recorder of Canby is hereby authorized and directed to post in six public and conspicuous places within the corporate limits of Canby, in Clackamas County, Oregon, for at least ten days prior to Tuesday, February 21, 1922, Notices of the Special City Election to be held in Canby on that date, which said Notices of Election shall state the date upon which said election shall be held, and shall designate the purpose of said election, and the names of the judges and clerks, which said notices shall also give the ballot title of the proposed addition to the charter of Canby.

Said judges and clerks are hereby named as follows:

For judges: L. H. Wang and F. A. Weygandt; for clerks; T. B.

Hamilton, A. H. Knight and O. W. Krueger, which said judges

and clerks shall receive as full compensation for their ser
vices as such, the sum of Three (\$3.00) Dollars per day, each.

The Election Ward of Precinct, for such Special City Election shall be and shall constitute all of the territory within the corporatelimits of Canby.

That there shall be one polling place for said Special City Election, to-wit: In the Council Chamber of the City Hall.

AND WHEREAS, it is necessary that this Resolution be immediately adopted to preserve the peace, health and safety of said City; and

WHEREAS, it is necessary that the City shall own, maintain and operate a municipal electric transmission and distributing system to light the streets of Canby, Now therefore, an emergency is hereby declared, and this Resolution shall take effect as soon as it is passed by the Council and approved by the Mayor.

On roll call: Ayes: Bair, Dedman, Eid, Evans, Johnson, Sandsness and Shull. Noes: None.

Whereupon, the Mayor declared the same duly passed, and immediately approved a copy thereof.

It was moved and seconded, that the matter of Mr.

Nelson's sign permit be left to the Committee on Streets and

Public property, with power to act. Motion carried.

Whereupon the Council proceeded to ballot for a City Treasurer. On the first ballot, John Eid received four votes, and Arthur Graham three votes. Whereupon the Mayor declared John Eid, duly elected Treasurer.

Whereupon, John Eid, resigned as councilman. It was moved and seconded that the resignation be not accepted. On roll call: Ayes: Eid. Noes: Bair, Dedman, Evans, Johnson, Sandsness and Shull.

It was then moved and seconded, that the resignation of John Eid be accepted. On roll call: Ayes: Eid, Johnson, Sandsness and Shull. Noes: Bair, Dedman and Evans.

Whereupon it was moved and seconded, that the election of councilman to fill the vacancy, be indefinitely postponed. On roll call: Ayes: Bair, Dedman, Evans. Noes: Johnson, Sandsness and Shull.

Whereupon the Mayor cast his ballot and declared the motion lost.

It was moved and seconded, that the election of councilman be postponed until the next regular meeting. Carried. Whereupon the following letter was read:

It was moved and seconded that said Ordinance be placed on its final passage.

On roll call: Ayes: Dedman, Evans, Johnson, Sandsness, Sheldon and Shull. Noes: None.

Whereupon the Mayor immediately approved a copy thereof and declared said Ordinance in full force and effect.

Whereupon the following Resolution was read:

Whereas, the Council of the City of Canby believes that it is desirable that a municipal light and power trans-mission and distributing system be constructed within the City of Canby; and

Whereas, it is necessary that the City Charter be amended to provide necessary funds therefore:

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Canby that the following amendment to the Charter of Canby be proposed and submitted to the legal voters of Canby by this Resolution of the Council of Canby without any initiative petition, said election to be held on the 21st day of February, 1922, and that this Resolution shall upon its adoption by the Council of Canby be marked by the Recorder filed, as such proposed amendment to the Charter of Canby, and that the Recorder of Canby shall cause to be printed and distributed a sufficient number of copies of said proposed amendment to

said Charter as may be necessary to distribute to the voters of Canby, and that notice be given by publication. That the Recorder shall give due notice of such election, and cause to be prepared the necessary ballot, notices and other matters for such election, and that the judges and clerks of such election shall be chosen by the Council hereafter, which Charter is entitled as follows:

"An act to incorporate Canby, in Clackamas County, State of Oregon; fixing the boundaries thereof; providing for the election and appointment of its officers; defining their qualifications their duties; their powers; and fixing their terms of office; providing for the organization of the City Council, the manner of the passage of ordinances, the establishment or alteration of the grade of any street or alley and for the improvement thereof, the building and repair of sidewalks, the laying out and establishing sewer districts and the construction of sewers and drains therein, the levying and collecting of assessments and the re-assessments for the cost of improvements of streets and alleys and the construction of sewers and drains; providing for a docket of City Liens, for the sale and redemption of property on account of delinquent assessments, for the condemnation of property for public use, for the issuance of bonds, for the owning, building and maintaining of water works for the said City; for the raising and expenditure of public money; for the liability of Canby; validating the past acts of Canby; fixing the terms of office of the present officials, and repealing all acts and parts of acts in conflict herewith"

together with amendments thereto; by the addition of Chapter 16.

Section 183. Canby is hereby authorized and empowered to issue and sell bonds of the City in a sum not to exceed Ten thousand dollars, bearing interest not to exceed six per centum per annum, and the Council of Canby is hereby directed to levy annually hereafter a tax on all taxable property in Canby in such an amount so that the same will provide the sum of Five hundred Dollars per annum on the principal and the further sum that will be required to be paid as interest during such year on the bonds issued as provided for in this Section of the Charter of Canby until the whole sum of said bonds, including principal and interesthas been fully paid and which tax shall be used solely for the purpose of paying the principal and interest upon said bonds; said tax shall be an addition to any other tax levied by the Council of Canby or provided for or limited by any provision of the Charter of Canby, and provided further, that said bonds may be paid at any time after two years from the date on which they are issued, upon thirty days' notice being given by the Treasurer of Canby previous to any interest date. The further terms and conditions under which these bonds shall be issued, shall be provided by Ordinance or Resolution adopted by the Council of Canby.
