Whereupon the following Resolution was read:

"WHEREAS, the owners of all of the lots in Block Sixteen (16) in Canby, have petitioned the Council of Canby for the vacation of the alley through said property, and

"Whereas, it appears to the Council of Canby that the said alley should be vacated; therefore,

"BE IT RESOLVED BY THE COUNCIL, That a Notice of the Pendency of said petition shall be given by publication in the Clackamas County News, a newspaper printed in Canby, which said notice shall be so published once a week for a period of thirty days, and shall state the time and place when said petition will be finally heard, and containing the description of the property to be vacated; and therefore,

"Be it further RESOLVED, That whereas, the City of Canby desires to construct its Water Work System in said Block, and it is necessary that said work immediately proceed, an emergency is hereby declared, in order to preserve the peace, health and safety of Canby, and to provide Canby with Water Works, and this Resolution shall go into immediate force and effect on its adoption and approval of the Council. "

Motion made and seconded that said Resolution be adopted.

On roll call; Ayes: Bair, Eid, Dedman, Johnson, Slyter, Sandsness and Shull. Nays: None.

Whereupon the Mayor declared said resolution

duly adopted, and immediately approved the copy thereof.


It was moved and seconded, that the City Treasurer be granted an additional leave of absence for sixty (60) days. Motion carried.
