

REGULAR MEETING OF THE CITY COUNCIL  
OF CANBY HELD AUGUST 1, 1921, Eight  
O'clock P. M.

The meeting was called to order by the Mayor.

On roll call the following officers were present: The Mayor, W. S. Maple, City Attorney, Philip Hammond, Recorder C. L. Eid, Chief of Police, George Meeks, Superintendent of Streets, H. H. Gillmore. Councilmen: Bair, Eid, Evans, Dedman, Johnson, Sandsness and Shull.

Minutes of the previous meeting were read and approved.

Whereupon the petition of certain citizens of Canby in regard to the street lighting system was read and laid on the table.

Communication of the City Attorney was read in regard to the tax levy for the year 1922. Laid on the table.

Whereupon the following Ordinance was read:

AN ORDINANCE TO PROVIDE FOR THE VACATION OF THE ALLEY IN BLOCK SIXTEEN (16) OF CANBY, AND DECLARING AN EMERGENCY.

## CANBY DOES ORDAIN AS FOLLOWS:

Section 1. That the alley through Block Sixteen (16) of Canby, according to the duly recorded plat thereof, filed in the office of the County Recorder of Clackamas County, Oregon, be and the same is hereby vacated.

Section 2. That the City Attorney of Canby shall have the change made on the Plat as required by the laws of the State of Oregon, showing the vacation of such alley, which plat is filed with the Recorder of Conveyances of Clackamas County, Oregon, and the charges of filing shall be paid by Warrant drawn by the Recorder and signed by the Mayor of Canby.

Section 3. Whereas, it is necessary to construct an addition

to the Water Work System of Canby in Block Sixteen (16) Canby, according to the duly recorded plat thereof, in order to provide Canby with fire protection and water, an emergency is hereby declared and this Ordinance shall go into full force and effect from and after its passage and approval by its Mayor.

Motion made and seconded that said ordinance be adopted and that such reading be considered as its first reading, and that the ordinance be posted for the reason that the charges of publication are in the judgment of the Council excessive, said ordinance to come up for final passage at a regular meeting of the Council of Canby to be held September 5, 1921, at eight o'clock P. M. Motion carried:

Whereupon the following Ordinance was read:

AN ORDINANCE PROVIDING FOR THE SALE OF THE SOUTH ONE-THIRD (S.1/3) OF LOTS ELEVEN (11) AND TWELVE (12) BLOCK SIXTEEN (16), AND FOR THE PURCHASE OF THE NORTH TWO-THIRDS (N.2/3) OF LOT TEN (10) BLOCK SIXTEEN (16) ALL IN CANBY, CLACKAMAS COUNTY, OREGON, AND DECLARING AN EMERGENCY.

CANBY DOES ORDAIN AS FOLLOWS:

Section 1. That the Mayor and Recorder for and on behalf of Canby shall execute a deed for the South 1/3 of Lots 11 and 12, of Block 16, Canby, Oregon, conveying said property to Bertha E. Lee.

Section 2. That the City of Canby shall receive in consideration of said conveyance, a deed conveying the North 2/3 of Lot 10, Block 16, of Canby, according to the duly recorded plat thereof, free from all incumbrances, which title shall be approved by the City Attorney.

Section 3. That said property in both deeds shall be described as "divided by a line drawn parallel to Third Street in Canby, Oregon" and the City of Canby shall convey to Bertha E. Lee the vacated portion of the alley through said block, if any there be, belonging to the City of Canby.

Section 4. That the Mayor and Recorder are hereby instructed to do and perform all necessary things to carry out the provisions of this Ordinance.



Section 5. Whereas, it is necessary to construct an addition to the Water Work System of Canby in Block Sixteen (16) Canby, according to the duly recorded plat thereof, in order to provide Canby with fire protection and water, an emergency is hereby declared and this Ordinance shall go into full force and effect from and after its passage and approval by its Mayor.


Motion made and seconded that said ordinance be adopted and that such reading be considered as its first reading, and that the ordinance be posted for the reason that the charges of publication are in the judgment of the Council excessive, said ordinance to come up for final passage at a regular meeting of the Council of Canby to be held September 5, 1921, at eight o'clock P. M. Motion carried.

Whereupon the Recorder of Canby announced that no bids had been received by the City of Canby for the paving on D and E Streets, and the Street Superintendent was instructed to proceed and lay the same.

It was moved and seconded that all of the street lights in the City of Canby be discontinued with the exception of the street lights controlled by the switch at the corner of C and First Streets, and which street lights are on First Street between A and E Streets; and that the Recorder immediately notify the Molalla Electric Company, and that the Chief of Police immediately collect the light globes from all of the remaining street lights. Carried.


