"An Ordinance giving and granting a franchise with rights to erect, maintain, use and remove poles, wires, cables and ducts, apparatus and appliances for conducting and using electricity in, under, upon and over any and all streets, alleys, roads, ways, public places and grounds of Canby, and to engage in the business of furnishing electrical energy to Canby, its inhabitants and to the public."
