SPECIAL MEETING OF THE COUNCIL OF CANEY, HALD OF DECEMBER 8, 1921.

The meeting was called to order by the Layer, W. S. Maple.

Chief of Police, Geo. F. Me ks. Councilmen: Dedman, Evans,
Johnson, Sandness, Sheldon and Shull.

Whereupon the following ordinance entitled:

"An ordinance for the purpose of levying a tax on all taxable property, both real and personal, within Ganby and declaring an emergency,"

was read.

Attached thereto was the following Affidavit of the Recorder:

That said capies were duly posted on November 23, 1921 and remained continuously costed for more than fourteen days.

The Mayor then declared the same passed and immediately approved a copy thereof.

M. J. Lee then asked for an extension of sixty days on his franchise. It was moved and seconded that Mr. Lee's Franchise be extended to sixty days. Carried.

Whereupon the following Resolution was read:
WHEREAS, it is necessary to establish Sinking
Funds for the Bond issues of Canby to pay such bonds at
maturity;

THEREFORE, BE IT RESOLVED by the Council of the City of Camby that the Treasurer of Camby shall and he hereby is directed to transfer the entire balance on hand in the General and Road Funds of Camby on the date of January 1, 1922 into two funds, which two funds shall be known as "Bond Retiring Funds, Nos. 1 and 2," said sum of money to be divided between such funds in the same proportion as the amounts of such outstanding issues of bonds.

Further, the Treasurer of Canby is hereby empowered and directed to invest such funds in the Sinking Funds of Canby in Warrants of the City of Canby not paid for want of funds.

Further, the Mayor and Recorder of Canby are hereby directed to issue a warrant for the outstanding indebtedness of the sidewalk paving district on C Street, which amount has heretofore been paid from the General Fund, and such warrant shall be turned over to the Treasurer of Canby and shall be held by him as part of such Bond Retiring Funds.

Whereupon it was moved and seconded, that said Resolution be adopted:

Whereupon it was moved and seconded, that the City
Attorney prepare an ordinance for the condemnation of the

electric light system in Canby, and such other procedure as may be necessary.
