The following resolution was then read:

Whereas, the Council of the City of Canby has set April 4th, 1921, as the date for the considering of objections to the certificate of the City Engineer of Canby, and of the assessments against the real property for the construction of the following described sidewalk:

Commencing at the Southwest intersection of First and C Streets, running thence South on the West side of C Street to Poplar Street; thence West on the South side of Poplar Street to Weed's Addition.

And Whereas, the Council has duly considered the report and has heard all persons appearing, now therefore,

BE IT RESOLVED BY THE CITY OF CANBY:

That such report shall be accepted by the City of Canby, as and for the assessments to be made against the property therein described and the Recorder of Canby shall indorse his approval on the certificate of the City Engineer.

Motion made and seconded, that said Resolution be adopted as read. On roll call, those voting Aye: Eid, Sandsness, Evans, Bair, Shull, Johnson and Slyter. Noes: None.

Whereupon, the Mayor declaredsaid resolution passed, and immediately approved the same.

Whereupon the following Ordinance was read, and adopted:

ORDINANCE NO. 165

An Ordinance declaring the assessment for the construction of the sidewalk commencing at the Southwest intersection of First and C Streets, running thence South on the West side of C Street to Poplar Street; thence West on the South side of Poplar Street to Weed's Addition.

Canby does ordain as follows:

Section 1. That the assessment for the construction of a sidewalk within the City of Canby commencing at the Southwest intersection of First and C Streets, running thence South on the West side of C Street to Poplar Street; thence West on the south side of Poplar Street to Weed's Addition, is hereby declared and levied according to the report of the City Surveyor, filed March 9th, 1921, and adopted by a resolution of the Council on April 4th, 1921.

Section 2. That the total cost of said improvement is \$940.65.

Read for the first time at a regular meeting of the Council of Canby, held April 4th, 1921, and ordered posted for the reason that the cost of publication was condidered excessive by the Council, and to come up for final passage at a regular meeting of said Council to be held on May 2, 1921, at 8:00 P. M.

Whereupon, the following Resolution was read:

Whereas, the City of Canby has duly adopted the assessment for the construction of a sidewalk on C and Poplar Street, and whereas, it is necessary that such assessment be collected, and whereas, the City of Canby has no proper lien docket,

Now, therefore, be it resolved by the City of Camby:

That the City Attorney of Camby shall prepare proper

notices to be sent to each of the property owners of the property

lying within the above named assessment district, which said notices

shall be mailed by the Recorder.

That the City Attorney shall purchase and secure for Canby a proper lien docket to enter such assessments in.

And that the recorder shall, with the assistance of the City Attorney, properly enter against the various pieces of property described in said assessment district, the liens created by Ordinance No. ___ of the City of Canby.

On motion made and seconded, said Resolution was adopted. Those voting Aye: Eid, Sandsness, Evans, Bair, Shull, Johnson and Slyter. Noes: None.

Whereupon the Mayor declared said resolution adopted and immediately approved the same.

The Recorder then read an Ordinance entitled, "An Ordinance providing for the use and regulation of vehicles on the streets and highways of Canby, providing for the punishment of violation of this act, and prohibiting the unauthorized use of such vehicles."
