Motion made that the bills be paid as read: On Roll Call, Ayes: Bair, Evans, Eid, Shull, Sandsness and Slyter. Noes: None.

Whereupon, the following Resolution was read:

"Whereas, it is necessary that the Treasurer of Canby attend the regular monthly meeting of the Council, so that the members thereof may be informed of the financial condition of Canby,

"Now therefore, BE IT RESOLVED, By the Council of Canby, that the Treasurer of Canby shall attend each regular meeting of the Council of Canby with the Treasurer's books."

It was moved and seconded, That said Resolution be adopted as read. On roll call: ^{Ayes} Bair, Evans, Eid, Shull, Sandsness and Slyter. Noes: None.

Whereupon, the Recorder read the following Resolution:

"Whereas, the owners of all of the lots in Block Sixteen (16) in Canby, have petitioned the Council of Canby for the vacation of the alley through said property, and

"Whereas, it appears to the Council of Canby that the said alley should be vacated; therefore,

"BE IT RESOLVED BY THE COUNCIL OF CANBY, That a Notice of the Pendency of said petition shall be given by publication in the Clackamas County News, a newspaper printed in Canby, which said notice shall be so published once a week for a period of thirty days, and shall state the time and place when said petition will be finally heard, and containing the description of the property to be vacated; and therefore,

"Be it further RESOLVED, That whereas, the City of Canby desires to construct its Water Work System in said Block, and it is necessary that said work immediately proceed, an emergency is hereby declared, in order to preserve the ^{peace} health, and safety of Canby, and to provide Canby with Water Works, and this Resolution shall go into immediate force and effect on its adoption and approval by the Council."

It was moved and seconded, that the resolution be adopted as read: On roll call, Ayes: Bair, Evans, Eid, Shull, Sandsness, and Slyter. Noes, None.

Whereupon, the Ordinance entitled "An Ordinance declaring the assessment for the construction of the sidewalk commencing at the Southwest intersection of First and C Streets, running thence South on the West side of C Street to Poplar Street; thence West on the South side of Poplar Street to Weed's Addition" to which was attached the following Affidavit:

It was moved and seconded that said Ordinance be placed on its final passage. On roll call, Ayes: Bair, Evans, Eid, Shull, Sandsness and Slyter. Noes, None.

Whereupon, the Mayor declared said Ordinance duly adopted.

Whereupon, the following Resolution was read:

"Whereas the City Engineer has filed a certificate of the completion and his approval of the work so completed on the construction of a sidewalk commencing at the Southwest intersection of First and C Streets, running thence South on the West side of C Street to Poplar Street; thence West on the South side of Poplar Street to Weed's Addition,

"Now therefore, be it resolved by the Council of the City of Canby, that the Recorder shall publish a notice of such com-

pletion by posting in three public places within said City for at least two full calendar weeks, a notice which shall state that the certificate of the Engineer has been filed, and that the work has been accepted by the City Engineer, and the same will be considered by the Council at the regular meeting to be held on June 6, 1921; and at that time or at any time prior thereto, any owner or agent of any property within the assessed district may appear or file objections to the acceptance of such improvement and such objection will be considered and the merits thereof determined by the Council at such meeting. And as there is an urgent need that this Resolution go into immediate force and effect in order that said improvement may be completed and provide for the peace, health and safety of Canby, an emergency is hereby declared to exist, and this Resolution shall go into full force and effect upon its adoption and approval."

Motion was made that said Resolution be adopted as read. On roll call, Ayes: Bair, Evans, Eid, Shull, Sandsness and Slyter. Noes, none.

Whereupon, the Mayor declared said Resolution duly adopted and approved the copy thereof.

It was moved and seconded, that the Committee on Streets and public property instruct the Engineer to cut down the tree in front of the First National Bank. Carried.

Whereupon the meeting adjourned.
