

Special Meeting of the Council.

Canby, Oregon, November 7th 1918.

Council met in special session and called to order by Mayor W.H.

Bair; There were present Mayor W.H. Bair Recorder C.N. Wait Chief of Police C.E. Bowman and Councilmen John Eld, C.C. Combs Ora Slyter, C.G.W. White and H.B. Evans; After roll call on motion made seconded and carried the Council proceeded to canvass the vote cast at the regular City election held on November 5th 1918. at which election there were elected one Mayor, one City Treasurer and eight Councilmen. Upon canvassing the vote it was found as follows, to wit:

Sandsness, Ora Slyter, and C. R. White be and they hereby are declared

to have been elected as Councilmen of the City of Canby for the

term commencing January 1st 1919. Upon motion and second the

resolution was duly carried.
