On motion Ora Slyter appointed a committe to see Standard Oil Co, and see about making a contract for pufchasing oil for a certain length of time at a less rate than the City is paying at present. Mr Robinson addre _essed the Council at some length on the subject of the City purchasing a moter and power from him to aid in part or wholly, the present pumping plant, moved seconded and carried that the Mayor appoint a committe of three to further confer with Mr Robinson in the matter: Thereupon the Nayor appointed as such committe, John Eid, Ora Slyter and C.V. White. Moved seconded and carried that a resolution be sent to the victory memorial Committe endorsing the Victory Highway between Portland and Salem on the West side of the Willamette river, passing through Camby.

Wayor Bair then extended his thanks to the members of the Council for their aid and assistance to him in the past and wished them good luck and success in the future. Council then adjourned.
