Hammond being called for service in the U. S. Army, for this meeting or any adjourned meeting of the council and until the next regular meeting in October 1917. Motion carried.

Motion was made by Councilman Wang, seconded by Councilman Slyter that these bills be allowed and that the Recorder draw warrants for the same. Motion carried.

The bill of Carlton & Rosenkrans Company was ordered returned to be itemized.

Councilman Dr. Dedman, Chairman of the Committee on Streets and Public Property reported that he had called upon Mr. Summerfield relative to the matter of the City purchasing a piece of land for the purpose of reducing the curve in the Pacific Highway at the Northwest corner of Mr. Summerfield's land and that Mr. Summerfield had agreed to sell to the City a piece of land 90 feet running East and West and 25 feet running North and South for the consideration of Fifty Dollars (\$50.00).

Moved and seconded that Committee on Streets and Public Property obtain deed for this piece of property from Mr. Summerfield and that a warrant for \$50.00 be drawn and that same be delivered to Mr. Summerfield upon his execution and delivery of a satisfactory deed. Motion carried. Ayes: Wang, Slyter, Combs, Evans and Dedman. Noes: None.

Moved and seconded that Councilman Slyter be appointed a committee of one to make the necessary repairs at the pumping plant. Motion carried.

E. C. Bowman, Supt. of Water Works made application for an increase in his salary. The matter was taken under consideration and upon the suggestion of the Mayor was left for action at some later time.

Committee on Streets and Public Property was instructed to see that the streets to the Fair Grounds were sprinkled during the fair.
