Whereupon the Recorder read the following ordinance:

"ORDINANCE NO. 139

An ordinance providing for the compensation of the Chief of Police of the City of Canby.

Canby does ordain as follows:

SECTION 1. That the salary of the Chief of Police of the Gity of Canby shall be Twenty five and 100 \$100 (\$25.00) Dollars per month.

SECTION 2. That all parts of ordinances in conflict herewith be, and the same are, hereby repealed." and seconded

Motion made/that said ordinance be placed on its first reading, and that it be published. Motion carried.
