

MINUTES OF COUNCIL

October 2, 1916.

Regular meeting of the Council of Canby called to order October 2, 1916, by the Mayor.

On roll call the following were present: Mayor, W. H. Bair; Recorder, P. L. Hammond; Councilmen, Slyter, White, Graham, Wang, Combs Bates and Stacy.

The minutes of the previous meetings were read and approved.

The following ordinance was returned to the Council by the Mayor, being: "An ordinance appropriating the sum of \$965.00 to purchase an oil engine for the Canby Water Works, directing the Mayor and Recorder to enter into a contract therefor, and declaring an emergency."

Said ordinance has the following endorsement thereon: "I hereby return the above ordinance this 26th day of September, 1916, not approved.

Motion made that said ordinance be re-read and placed on its final passage. Carried. On roll call the vote was as follows: AYES: Councilmen Slyter, Graham, Wang, Combs, Bates and Stacy. NOES: Councilman White.


It was moved and seconded that the Recorder instruct the street commissioner and surveyor to immediately undertake the work heretofore ordered on the streets of Canby. Carried.
