MINUTES OF REGULAR MEETING

April 3, 1916.

Regular meeting of the City Council of Canby called to order by the Mayor at eight o'clock P. M.

On roll call the following were present: W.H.
Bair, Mayor; Philip L. Hammond, Recorder; J. W. Lieser,
Chief of Police; Councilmen Slyter, White, Wang, Stacy,
Graham, Combs and Bates.

The minutes of the previous meetings were read and approved.

A communication from Carlton & Rosenkrans was read, in which they offered to sell to the City of Canby, a transit. On motion this was laid on the table until the next regular meeting.

The recorder then read a communication from the City Attorney as follows:

"Canby, Oregon,
March 14, 1916.

To the City Recorder of Canby, Clackamas County, Oregon:

I herewith submit and return the ballot title for the proposed charter of Canby as follows:

- 1; Referred to the people of Canby, by the Council of Canby.
- 2; Charter for Canby, Clackamas County, Oregom.
- Purpose; Shall Canby adopt a charter validating
 its past acts; providing for election and appointment of its officers, defining their powers; providing the manner of passage of ordinances; the
 establishment or alteration of street grades, and for
 the improvement thereof, for the building of sidewalks and the construction of sewers by district
 plan; the assessment of abutting property for
 improvements, for the enforcement of all city
 liens, the condemnation of property for public
 use, the building and maintaining of water works
 and the raising and expenditure of public money

and the liability of said City.

I herewith submit and return the ballot title for the proposed addition to the charter of Canby, as I follows:

- 1; Referred to the pcople of Canby, by the Council of Canby.
- 2; Bond issue for Canby, Clackamas County, Oregon.
- Purpose; Shall Canby issue bonds in an amount not to exceed \$18,000.00, which shall draw interest at a rate not greater than six per cent. The money to be derived therefrom to be used for the purpose of building and maintaining a water works system in Canby.

On motion the above communication was ordered placed on file.

The City recorder then reported that he had that day received from M. J. Lee four initiative petitions with the request that they be filed in the Recorder's office, but that the recorder had not had sufficient time to check said petitions up before the meeting, and did not know whether or not said petitions had the required number of names and otherwise complied with the law which entitled them to be filed.

Motion made and seconded that said bills be allowed.

Whereupon, on roll call the vote was as follows:

AYES: Slyter, White, Wang, Stacy, Graham, Combs and Bates.

NOTS: None.

The Mayor then ordered the Recorder to draw warrants in payment of the same.

The Council received a report from the committee appointed to purchase a fire bell for the City of Canby, to the effect that the cheapest bell they could get would cost Seventy-seven and 50/100 (\$77.50) Dollars, F. O. B.

Northville, Michigam. Motion was made and seconded that the committee purchase, without delay, a double hammar fire bell, 40 inches in diameter, at the cheapest possible figure.

In regard to the matter of the ferry across the Willamette River, a motion was made and seconded that, provided money could be taken from the road fund, a committee of three be appointed to buy a new ferry, to spend not to exceed Two Hundred and fifty and 00/100 (\$250.00) Dollars. Carried. The Mayor appointed on this committee, councilmen, White, Slyter and Bates.

Whereupon, bids were opened by the Recorder for the printing of the city charter and measures to come up at a special city election to be held on the 19th day of May,

A. D. 1916. Said bids were as follows:

Canby Herals - - - - - \$1.85 per page

Courier Press - - - - 1.94 " "

Enterprise - - - - - 1.99 " "

Motion was made that the Recorder let said bid to the Canby Herald for \$1.87 per page. - Carried.

Motion made and seconded that the recorder should buy a new ordinance book for the City of Canby, which said book was to cost not to exceed Ten and 00/100 (\$10.00) Dollars.

On motion the council adjourned to meet on Monday, April 10th at eight o'clock P. M.
