May 22nd, 1916.

Adjourned regular meeting of the Council of Canby was called to order by the Mayor W. H. Bair on Monday, May 22, 1916, at eight o'clock P. M.

Motion made by Councilman Wang and seconded by Slyter, that J. Lee Eckerson be continued as temporary recorder to fill the vacancy caused by the sickness of the Recorder P. L. Hammond. Motion carried.

On roll call the following were found present: Mayor, W. H. Bair; Councilmen, L. H. Wang, P. O. Stacy, C. G. Combs, Ora Slyter, G. W. White, J. A. Graham, H. A. Dedman. Absent, George J. Bates. C. Bowlsby, marshall.

In the presence in the members of the Council, acting recorder J. Lee Eckerson canvassed the votes cast at the special election held on May 19, 1916, and made the following report:

"In the presence of W. H. Bair, Mayor of Canby in Clackamas County, State of Oregon, and of the Council of Canby, I, J. Lee Eckerson, acting recorder of Canby canvassed the votes cast at the special city election held in the City of Canby, Clackamas County, Oregon, on the 19th day of May, A. D. 1916, on an act entitled:

incorporate Canby, in Clackamas County, State of Oregon; fixing the boundaries thereof; providing for the election and appointment of its officers, defining their qualifications, their duties, their powers; and fixing their terms of office; providing for the organization of the City Council, the manner of the passage of ordinances, the establishment or alteration of the grade of any street or alley and for the improvement thereof, the building and repair of sidewalks, the laying out and establishing of sewer districts and the construction of sewers and drains therein, the levying and collecting of assessments and the re-assessments for the cost of improvements of streets and alleys and the construction of sewers and drains; providing for a docket of city liens, for the sale and redemption of property on account of delinquent assessments, for the condemnation of property for public use, for the issuance of bonds, for the owning, building and maintaining of water works for the said city; for the raising and expenditure of public money; for the liability of Canby; validating the past acts of

That there were no defective ballots not counted.

I therefore proclaim and declare said act adopted, approved, passed and carried by the legal

voters of Canby, and that said act is now a part of the charter and fundamental law of Canby, and shall be known as Section 140 of said charter.

That at said special election the total number of votes cast were 243; that of said title number of votes so cast there were cast for said act 188 votes; against said act 51 votes; that the majority of votes cast at said election for said act were 137 votes; that there were no defective ballots not counted.

I therefore proclaim and declare said act adopted, approved, passed and carried by the legal voters of tanby and that said act is now the charter and fundamental law of Canby.
