

## REGULAR MEETING OF THE CITY COUNCIL

November 1, 1915.

Regular meeting of the City Council of the City of Canby called to order on Monday, November 11, 1915, at eight o'clock P. M. by the Mayor. On roll call the following were present: The Mayor, Recorder, Chief of Police and Councilmen, Gillmore, White, Meeks, Stacy, Graham and Dedman.

The minutes of the previous meeting were read and approved.

The report of the auditing Committee was taken up and on motion of P. O. Stacy was adopted as set out in the minutes of October 4.

A communication was received from the Southern Pacific Company addressed to A. Stefani in regard to the lease, and the Recorder was instructed to take this matter up with the Southern Pacific Co. and secure a transfer of this lease to the City

A communication was also received in regard to the Park on the Southern Pacific Right of Way. This matter was laid on the table.

Motion made that said bills be paid, and that the Recorder draw warrants for the same. On roll call the vote was as follows:

The report of the Committee on Streets and Public Property in regard to lights to be put in by the Molalla Electric Company was received. They reported no lights installed.

The Committee appointed to purchase a fire bell for the City of Canby was instructed to see M. J. Lee and obtain from him the price of a fire bell.

The budget for the City of Canby drawn up by the Recorder under direction of the Council was received, a copy of which here follows:

To maintenance of executive department of City:

To pay general expenses (including printing, postage, attorney's fees, fees of Recorder's office, telephone charges, annual cost of preparing budget, stationery, publishing monthly expense accounts, expenses of auditing City's Books annually, money for charitable purposes, interest on warrants not paid for wants of funds, etc.) - - - - - 300.00

To maintenance of Recorder's Court:

To cover witness fees and other court costs, upkeep of jail, meals to prisoners, etc - - - - - 50.00

To maintenance of police department:

For special police during Fairb- - - - - 40.00

For special police, for fees allowed Chief of Police, according to City Charter, for other costs of police department, as maintenance of City pound, taking care of stray dogs, collection of dog licenses, prevention of nuisances, etc. - - - - - 50.00

Engineering:

For charges of engineers for giving grades for street cross walks, etc - - - - - 50.00

General repairs for City buildings:

- - - - - 50.00

Fuel for City

Wood - - - - - 20.00

Cross walks and side walks:

For cross walks across the streets in Canby, and repairs of walks in front of City property, prescribed by the charter to be paid from the general fund of the City - - - - - 600.00

To maintenance of ferry:

To salary of ferry man - - - - - 150.00

To Fire Department:

To purchase fire alarm and tower for same - - - - - 75.00

To City Election:

To salaries of clerks, judges and printing etc - - - - -	30.00
To salary City Treasurer:	
Salary of the Treasurer is on the fee basis and is estimated at - - - - -	50.00
To deficit of 1915:	
It is estimated that there will be a deficit in the City Treasury of - - - - -	<u>260.00</u>
Total - - - - -	\$ 2728.00

Sources of Revenue of the City of Canby:

General revenue from sources other than taxes:

From fees - - - - - (very little or nothing)	Unknown

This budget for the City of Canby includes nothing for the improvement of roads or streets; if we have any money for that purpose it will come from the road tax of Clackamas County, if the tax payers of the County see fit to levy the annual road tax. The estimated value of the road tax from this source during the year 1915, which will have been paid to the City of Canby, if there are no unpaid taxes at the close of the year is \$1,811.12. The revenue from this source cannot be determined until the tax is levied and paid.

We respectfully submit the foregoing budget for the Council of the City of Canby.

The following Resolution was introduced and unanimously adopted:

BE IT RESOLVED by the Council of the City of Canby, that the budget proposed by the Committee on Streets and Public Property and the Recorder, under the direction of the Council, be and the same is hereby accepted and adopted by the Council for the City of Canby.

The following ordinance was introduced:

ORDINANCE NO. 123

An Ordinance for the purpose of levying a tax of seven and one-half mills on all the taxable property, both real and personal within the City of Canby.

CANBY DOES ORDAIN AS FOLLOWS:

Section 1: That the City Council of Canby does hereby levy a tax of seven and one-half ( $7\frac{1}{2}$ ) mills on all the taxable property, both real and personal which is taxable for state and county purposes within the corporate limits of the City of Canby, to be collected as other taxes are collected in the State of Oregon, by the Treasurer and Tax Collector of Clackamas County, during the year 1916, with the taxes commonly known as the taxes of 1915.

Read for the first time and ordered posted at the regular meeting of the Council of the City of Canby held on the 1st day of November, A. D. 1915, and to come up for

final passage at a special meeting of the said Council to be held on Monday, the 22nd day of November, A. D. 1915, at 7;30 o'clock P. M. at the City Hall."

Ordinance No. 122 being an ordinance providing for fire limits, and the construction and equipment of buildings in the City of Canby and providing for the issuance of permits for construction purposes and providing a penalty for the violation of this ordinance, which was read for the first time and ordered posted at a regular meeting of the Council of the City of Canby held on the 4th day of October, A. D. 1915, and to come up for final passage during the meeting of said council to be held on the 1st day of Nov. A. D. 1915, at eight o'clock P. M., has the following affidavit attached thereto:

Motion made that said ordinance be placed on its final passage. On roll call the vote was as follows:

AYES: Gillmore, White, Meeks, Stacy, Graham and Dedman,

NOES: None.

The ordinance was declared passed by the Mayor.

At this time the Recorder reported that M. J. Lee had filed in the Recorder's office an initiative petition signed by seventy-one voters and citizens of the City of Canby initiating the following ordinance:

"Entitled an ordinance declaring it a nuisance for dogs to run at large in the City of Canby, and declaring it a misdemeanor for any person to permit a dog to run at large and prescribing a penalty therefor and authorizing the police to take up said dogs, to keep and post a notice of taking and to release or kill the same.

CANBY DOES ORDAIN AS FOLLOWS:

Whereas, a large number of dogs have been running at large within the City of Canby, and whereas such dogs are not muzzled, and whereas such dogs are continually damaging and destroying property of the citizens of Canby, and whereas, there is danger from such dogs running at large causing hydrophobia, and whereas such condition of affairs is damaging to the health, safety and happiness of the citizens of Canby, and to the property of the said citizens, now therefore, as such conditions of affairs should be remedied:

Section 1: That from and after the passage of this ordinance, in order to preserve the peace, safety and health of the citizens of Canby and to prevent the property of the said citizens from being destroyed and damaged, it shall be a nuisance for dogs to run at large within the City of Canby. And it is hereby declared by this



ordinance that it shall be deemed to constitute and to be a nuisance for any dog to run at large within the City of Canby.

Section 2; That if any person shall permit any dog belonging to or in the charge of such person to run at large within the City of Canby, such act or acts shall constitute a nuisance and are hereby declared to be a nuisance and dangerous to the peace, health and safety of the lives of the citizens of Canby and of the property of such citizens.

Section 3, That if any person shall permit or suffer any dog to run at large within the City of Canby they shall be guilty of a misdemeanor, and it is hereby declared to be a misdemeanor for any person to permit any dog or dogs, the property of such person to run at large within the corporate limits of the City of Canby.

Section 4, Any person found guilty of a misdemeanor as defined by this ordinance, shall upon conviction thereof in the Recorder's Court of Canby, be fined not more than Ten Dollars and costs.

Section 5, That the Police of the City of Canby are hereby ordered, authorized and empowered to catch and take all dogs running at large within the said City, and keep said dogs in the City pound. That the chief of police shall post a notice for at least five days of such taking of any dog, and if the owner shall not appear within said time, shall kill and bury said dog. If said owner shall appear and claim said dog, it shall be released to such person only upon their paying the cost of keeping said dog, and the sum of One Dollar for taking up and posting said notice. If said fee is not paid, together with the cost

of keeping, within five days from the posting, said dog shall be killed whether claimed by the owner or not."

Motion was made that said ordinance be laid on the table and that no action be taken on the same by the City Council. Carried.

The matter of the appointment of the judges and clerks for the coming election was brought up and nominations being in order,- as judges were nominated George F. Bates, B. H. White, Warren C. Kendall, and as clerks, Mrs. Adam Knight and Mrs. John Graham, Motion was made and carried that nominations be closed. It was moved that the Council declare the said judges and clerks to be and they were elected by the Council.

The Recorder was instructed by the Council to secure ballots and other necessary supplies for the coming election.

The request of the Boy Scouts that they be permitted to install athletic apparatus within the City Hall was granted, provided said apparatus did not interfere with the <sup>use of the</sup> City Hall for auditorium purposes.

The Street Commissioner was instructed that if A. Stefani did not deliver the lumber for cross walks, within one week, to purchase it elsewhere.

On Motion meeting adjourned.
