Letter from the Molalla Electric Company in regard to fire bell for the City of Canby read and the City Council order the Recorder to inform the Molalla Electric Company that the City would be unable to use the fore bell the Company had offered, and that the estimnates of the costs should be returned as requested.

Estimuate on the costs of painting a part of the City
Hall received, Councilman Gillmore and the Committee on Streets
and Public Property were ordered to look the matter up and have
the lower floor fixed up.

Request of Wirfel for a lease for a year on the lower floor of the City Hall received. Councilmen Gillmore and White named a committee to enter into a greement with Mr Wirfel as to the matter of a lease

The Mayor appointed Gillmore and White a committee to

place the fure bell on two tall poles some where in the City, on First Street, if possible, and out side of the property line.

At this time the Boy Scouts of Canby requested for the privilage of using the City Hall, so that they might have some place in which they could meet. The Council agreed that they might use the Hall on such nights as they wished, provided they would not interfere with the City Councils meetings on the nights that the Picture Show was going on in the floor below.

M. J. Lee agreed to pay for the grading which was done on the street in front of Lee's Second Addition to Canby, at this time, and agreed that he would pay the cost of advertising the franchise which he secured from the City Council to place electric poles and wires on the streets of Cqnby, at the time the clause in the franchise expired, if he had not completed his work under the franchise as he agreed to do.

The Committee on Streets and Public Property turned in an unfavorable report on the construction of a concrete gutter down C. and First Streets to G. Street, and agreed to further report at the next meeting.

Adam Enight, the Street Commissioner turned in a report on the work he wishes to do, and asked for instructions from the Council concerning street inprovements, and desired the Council to inform him as to where they wished improvements placed and the amount of money he could expend. He futher agreed to report to the Council the cost of a street grader. Grant White of the Committee of Streets and Public Property reported that gravel secured from New Era was the only kind that should be used on the streets in the City of Canby.

Motion made that the street commissioner be allowed a sum not to exceed Two Hundred Dollars for street improvements, - bills for which are to be sent in to the Council as usual. Carried.

The Mayor at this time appointed Monday, the first day of March 1915, as general clean-up day for Canby.

Moved that the Council hold a special meeting Monday the 8th day of Feb. 1915, and that this meeting adjourn. Carried.
