Motion, that the City of Canby expend during the coming year the sum of \$2000.00 for street improvements on C. St. from First to Second St. and on First St. from A. to E. Streets. Carried.

Motion made that the Street Commissioner be instructed to interview Carlton & Rosenkranz and The First National Bank and find if they will pay one-half of the cost of the construction of a concrete gutter on C St. between First and Second Sts. . If so, to construct the gutter. Carried.

At this-time the Council took up the matter of/helping certain poorland needy persons in the City of Canby.

The following RESOLUTION was adopted:

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CANBY:

That the sidewalk located on the East side of C St. from the South line of the Southern Pacific Company's main track in the said City, and the North line of the street on the South side of the Southern Pacific Co's right of way may be built, repaired and

constructed. That said sidewalk or cross walk shall be eight feet wide.

That notice of this resolution be served upon the owners of abutting property, or if said service cannot be secured, that said notices be posted. "

That the following resolution was also adopted at said council meeting:

*BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CANBY:

That whereas, heretofore viewers were duly appointed by the City Council of Canby to view certain property for the proposed opening of Fair Street, that said viewers duly met and thereafter reported to the Council; that said report was duly accepted by ordinance, which said ordinance was passed by the Council on the 9th day of December, 1914, and is now in full force and effect.

That therefore, it is hereby ordered that the Recorder shall enter in the docket of City Liens the respective sums of benefits over damages, so assessed upon each particular lot or parcel of land, and the names of the owners or other parties interested in the lands or property benefited or assessed, in like manner as assessments for street improvements are entered in said lien docket.

On motion Council adjourned.
