

MEETING OF THE CITY COUNCIL

Regular meeting of the City Council was called to order at eight o'clock P. M. April 5th, 1915, by the Mayor, Honorable William Harrison Bair. On roll call the following were present: The Mayor, recorder, Chief of Police and councilmen Gilmore, Wang, Sutherland, White, Meeks and Graham.

The minutes of the previous meeting were read and approved.

The Recorder made the following report for the first quarter of the year 1915:-

"To the Council of the City of Canby:

I hereby report to you that the Recorder has issued in the first quarter of the year 1915, warrants as follows:

In the month of January general warrants \$406.50 and road warrants \$343.20, a total of \$749.70.

In the month of February, general warrants \$109.36, and road warrants \$170.95, a total of \$280.31.

In the month of March, general warrants \$515.24 and road warrants \$158.85, a total of \$674.09, this included a warrant for \$325.00 to Frank Dodge, provided for in the last quarter of the year 1914, for the City Jail, making the total general warrants issued exclusive of the said warrant, \$190.24, and total warrants, \$349.09.

That the total warrants issued for general purposes during the first quarter was \$1031.10, and total warrants for road purposes was \$672.05, the total warrants issued for all purposes was \$1703.15.

That the Treasurer reports he has received the sum of \$400.73 during the said quarter, for which the recorder has received receipts.

That the Recorder's books show a balance of \$2266.02 January 1, 1915, making a total of \$2666.75, leaving a balance of \$963.50.

The City attorney reported as follows: That he had examined the exhibits submitted by O. R. Mack for Fair Street, the property which was recently condemned by the City for street purposes. That he found said property free from incumbrances; that he duly prepared plat and tracing of the proposed street as required by the City Charter and the laws of the State of Oregon, which were signed by the City Engineer, and that he had delivered to O. R. Mack a warrant for \$125.00. And that said street is now the property of the City of Canby.

The matter of purchasing asphaltum for the streets of the city, from the Standard Oil Company, was discussed at this time, and the offer of the Standard Oil Company to prepare

plans and specifications for river washed gravel streets bound by asphaltum, was accepted.

The Recorder was instructed to note the arrival of Councilman Henry A. Dedman, at this time.

The following bills were then read: One of the bills of the Canby Transfer Company was ordered returned to them to be O K'd.

On motion the Recorder was instructed to draw warrants for said bills. On roll call the vote on said motion was as follows: Ayes- Gilmore, Wang, Sutherland, White, Meeks, Graham and Dedman. Noes- None.

The Street Commissioner, Adam H. Knight made a report in regard to the above bills for street work, which said report was as follows:

"Of the attached March report, \$145.79 is chargeable to account of installing gutters on Second St. & C. St. of which expense C. & R. Co, have agreed to pay half of that part which abuts their property and The First Nat'l. Bank have also agreed to the same terms."

The Committee on Streets and Public Property reported that they had made no arrangements to purchase the fire bell, nor erect same on tall pole on First St. and asked for further time. They were granted not to exceed one year.

At this time M. J. Lee addressed the Council and requested that the City purchase a transit for \$200.00, This matter was laid on the table.

The chief of police was instructed to purchase a bed for the city jail, no provision having been made for the same heretofore, for any of the cells in the jail.

The Recorder was instructed to make some arrangements with Mr. Wirfel, the man who rents the lower floor of the City Hall, that the chairs belonging to the city of Canby be returned to the Council chambers.

W. H. Bair reported that he had seen the General Freight Superintendent of the Southern Pacific System, and that he had made arrangements to secure gravel laid down in Canby, at a rate of not to exceed ninety cents per yard. That this rate would be verified by letter, which he had not yet received.

The Street Commissioner, Adam Knight reported that he had constructed a gutter, commencing on the west side of the entrance to the shed belonging to C. & R. Co. on Second St, running down C. Street to First Street. That this gutter had cost about fifty cents a running foot. He was instructed to continue the gutter on First St. East, if the gutter which has already been constructed would carry

the water off.

Motion made and seconded that the list of warrants issued by the City Recorder be published in the Canby Herald, at a price not to exceed five cents a line. Carried.

The matter of the City of Canby contributing a certain sum of money to a library in the City was brought before the Council at this time, and the Council was addressed by M. J. Lee, who requested that some aid be given. Motion made that Five Dollars a month be contributed to the library. The Recorder to present a bill each month to be paid as other bills are for city purposes. . On roll call the vote was as follows:

Ayes: Gilmore, Wang, Sutherland, White, Graham, Dedman,
Noes: Meeks.

The Water Committee made the following report: That the City could put up a water tank and install water mains and fire hydrants, and that M. J. Lee would furnish the water into said tank free of cost. The Council was further informed that a seventy foot wooden tank holding 50,000 gallons could be constructed for Two Thousand and no/100 (\$2000.00) Dollars. The cost of the tank constructed at Woodburn, being a steel tank and steel tower was Four Thousand Five Hundred and 00/100 (\$4500.00) Dollars.

The City Council was informed of the status of the case of the City of Canby vs. Clackamas County.

On motion meeting adjourned.
