REGULAR SESSION OF THE CITY COUNCIL, MONDAY, APR. 6, 1914.

The City Council of the City of Canby, Ore. met in regular session in the City Hall, at 8:00 o'clock P.M. on Monday, Apr. 6, 1914 and was called to order by Mayor, W. H. Bair.

Upon roll call the following were found present, to-wit:- Mayor, W. H. Bair; Recorder, C. F. Romig; Chief of Police, J. W. Lieser; Councilmen, J. L. Eckerson, H. C. Gillmore, L. H. Wang, H. J. Hewett, Grant White, J. E. Sutherland, Geo. Meeks & P.O. Stacy.

Minutes of the previous meeting read, approved and ordered placed on file.

Under communications, letters, that were received from various firms, offering to supply us with a front and 2 solid steel partitions, bunks (one for each cell, 3 in all) and 3 soil buckets for 3 jail cells, were read. The prices quoted ranged from \$180.00 to \$290.00. Motion was made, seconded and carried that E.T. Barnum Iron Works' \$180.00 proposition be accepted, if they deliver material F.O.B. Canby, and if not then the Committee on Streets and Public Property be authorized to place the order where they might see fit and proper.

Motion was then made, seconded and carried that the Mayor,

Ordinance #115, relative to the franchise for lighting Canby, said system to be installed by M. J. Lee, was then taken up. Motion was then made by Councilman Wang, seconded by Councilman Hewett that it be placed on the table. Motion carried.

Motion made, seconded and carried that Council adjourn to meet again April 13, 1914 at 8:00 o'clock P. M.

April 13, 1914.

The Council of the City of Canby met in its regular adjourned session in the City Hall at 8:00 o'clock P. M. on Monday, Apr. 13, 1914, and was called to order by Mayor W. H. Bair. Upon roll call the following were found present:- Mayor, W. H. Bair; Recorder, C. F. Romig; Chief of Police, J. W. Lieser; Councilmen, J. L. Eckerson, H. C. Gillmore, L. H. Wang, J. E. Sutherland, Geo. Meeks and P. O. Stacy.

Under communications: The resignation of Wilso Evans was presented: whereupon this resignation as Street Commissioner was upon motion duly accepted.

Ordinance # 115, relative to the franchise, was taken from the table, read and after much discussion, motion was made that the Mayor appoint a committee of three to revise it. Motion carried and Councilmen, Gillmore, Sutherland and Eckerson were duly appointed by the Mayor.

Motion was then made that viewers be elected to view the opening of Fair Street and that the viewers meet April 18, 1914 at 3 o'clock P. M. at the City Hall. motion carried, whereupon Messers Adam Knight, C. A. Bradford and C. L. Bates were nominated and elected. The Recorder was instructed to serve notice on the viewers appointed and also on Roscoe Mack, the only land owner directly concerned.

Motion made, seconded and carried that all Street work be continued under the direction of the Committee on Streets and Public Property and the Chief of Police.

Council adjourned.
