

Minutes of City Council Jan 6, 1913.

The City Council met in regular session Jan 6, 1913 at 8:00 o'clock P.M. at the City Hall by Councilman H. C. Gillmore, Pres. of the Council, Upon roll call the following responded: - Recorder C. F. Romig, Chief of Police E. C. Shull, Councilmen: H. C. Gillmore, J. L. Eckerson, John Graham, J. E. Southland, H. J. Hewitt, L. H. Wang, Grant White and W. H. Bair.

Minutes of the previous meetings of Dec. 4 and Dec. 9 were read approved and ordered placed on record. The following Claims against the City were then presented: -

Motion made by Councilman Eckerson seconded by Councilman Graham that the bills be allowed and warrants be ordered drawn to pay same, whereupon the roll was called & the motion was carried unanimously, all the Councilmen present voting "yes."

Councilman Eckerson reported that he found a suitable fire alarm.

Ordinance #111, relative to the opening of the road through the gravel pit was read, approved and ordered posted. Said ordinance was scheduled to be considered for final passage at next regular meeting, the first Monday

in Feb. 1913,

The Lease prepared and presented by the Southern Pacific R. R. Co. relative to the watering trough was read, approved and ordered executed.

Motion made & carried that Side walks be ordered put in by Street Commissioners on the East side of "C" Street, between Fourth and Seventh Streets also on the West side of "B" Street from Holliner's Corner to the intersection of Sixth St. and in either case ~~of~~ a walk of not less than six feet be insisted upon.

Whereupon the Street Commissioner ~~was~~ authorized to notify the property holders to build these walks.

The Council then proceeded to elect the Recorder, Chief of Police, Street Commissioner and President of the Council, said officers being balloted upon with the following results:-

For President of the Council:

J. I. Eckerson	received	two	votes
H. C. Gillmore	"	five	"
and Grant White	"	one	"

Whereupon H. C. Gillmore was duly declared elected.

For City Recorder for a term of 1 yr.

C. F. Roring received eight votes, and he was declared duly elected to that office, there being no other person who received any votes.

For Chief of Police for a term of 1 yr.

E. C. Shull received eight votes and he was declared duly elected to that office, he being the only person receiving any votes.

For Street Commissioner for a term of 1 yr.

Wilson Evans received 6 votes.

For Treasurer " 2 votes.

Whereupon Wilson Evans was declared duly elected Street Commissioner.

Whereupon it was suggested that two deputies be named for regular police by Chief of Police, E. C. Shull, who named Joe Liseser and Chas. Combs. Motion made, seconded & carried that these two deputies named be confirmed.
