 do any necessary work under instruction of
 Committee on Streets and Public Property.
 After some talk in regard to County tax levy
 for Roads, It was moved and Carried that a
 City tax levy of 5 Mills for City purposes for
 the year 1911, be made and that Recorder draw
 Ordinance to that effect
