

The City Council met in reg. session on the 1st day of March 1909, and was called to order at 8 O'clock P.M. by the Mayor J. F. Witto & Present: the Mayor, Recorder and Chief of Police and Councilmen Bair, Bates, Gellmore, Graham, Fisher, Hilton, Wait and Evans, Minutes of last reg. & Spcl Meetings were read and Stroud approved after which: a petition, signed by Geo. Fletcher, J. L. Eckerson, and 36 Other Citizens of County, was presented and read by the Recorder; said Petition was addressed to the Hon. Mayor and City Council of County and represented, that there were no parks, nor public places of amusement, where the residents may gather on Sunday, and that certain Callings, including Pool rooms, were conducted in a quiet and orderly manner, therefore, the petitioners, petition the City Council, that the above places of business, including Pool rooms, be allowed to operate and remain open on Sundays &c. = and after due consideration it was moved and seconded, that the petition be indefinitely postponed. The Motion Carried, and was so Ordered & after which, the following claims were read, Audited and Ordered paid by unanimous vote of the Council.

The Claim of A. Kocher, amt. 50 cents for 2 globes was laid over, for investigation, to next meeting. In the matter of Fire Extinguishers being frozen busted and damaged; It was ordered that the Committee on "fire & water" investigate, and report the condition of said Extinguishers; In the Matter of Draining first Street: which matter was taken up for consideration, at the last Spcl. Meeting Feb. 16th & the Street Supt. was instructed to make a ditch, in accordance with a draught or plat in his possession: made by Engineer Jesse Hill &

In the Matter of Stock running at large within the City Limits. After due consideration, It was Moved and Seconded, That a Special Election be held in the City of Canby on the 20th day of March 1909. for the purpose of voting "for" or "against" Stock running at large within the City Limits of the Town of Canby. The Motion Carried and was so Ordered, And the Recorder was instructed to give ten (10) days Notice of said Election, and to begin at 2. O'clock, and close at 7. O'clock in the afternoon of March 20th 1909, in the City Hall in Canby, and that W.H. Bair, Chas. J. Roth, and H.C. Gillmore are appointed as Judges, and L.E. Grazer and Wilson Evans as Clerks. to conduct the Election, and that said Judges & Clerks, are requested to serve without compensation therefor, and that the Recorder procure, and prepare, Ballots, Poll-books, Tally sheets and all the necessary articles to carry on said Special City Election.

In the matter of Special Committee appointed at the Reg. Feb'y meeting, to confer with interested parties in reference to establishing a roadway from South boundary of City limits, into the streets of Canby, the Committee reported, (verbally) that the parties interested in a proposed roadway, had not yet agreed upon any certain route, and had not procured any right of way from any one, along any part of the proposed road, and that no estimate had been made of the probable cost of any suitable right of way, in the premises; therefore, the Committee is unable to make any definite report in the matter of establishing a road; The committee stated, that they were informed, that Mr. Wheeler had offered an outlet along the east line of his land up the bluff where the road would lead into Mack. Burns & Knight road, no action was taken, and the matter left open for future consideration.

after which the Street Supt. was permitted to drain, and repair some other roads, and that streets should be cleared of rubbish, &c,

after which the Ordinance, to license trades callings &c. was taken up and read second time and motion duly seconded and carried, was placed on its final passage, a vote was taken, which resulted in seven councilmen voting "for" and "one" vote against passing the Ordinance, F. H. Hilton voting "no." The Ordinance passed, and was so declared, In the matter of the rent collected from A. Koche on lower rooms of City Hall, The finance Comm. was instructed to investigate, and ascertain as to whether the rent had been collected up to Jan'y 12th 1909, or up to Dec, 12th 1908, and report their findings at the next reg. meeting in Apr. After which; upon motion, duly seconded and carried, the Council adjourned in due form: William Knight Recorder.

The Council met on the 5th day of April 1909 and was called to order at 8 o'clock P.M. in reg. session, by Mayor J. F. Witts. A full Council was present, except F. H. Hilton. Minutes of last meeting read & stood approved after which, the 1st City Report of the City Treasurer was read, and accepted, showing a bal. in the City Treasury March 31st 1909, of \$330.02 - not including a certain check, of \$20.00 not collected after which the following claims against the City were read, audited and ordered paid by unanimous vote of all Councilmen present.
