

In the matter of turning off of street lights
Ordered that all lights be turned off
except on first street.

Ordered; that the Canby Band be allowed
space on the back part of the stage in the
City Hall. to construct a closet for the purpose
of storing insured instruments.

In the Matter of an application from
H.C. Gillmore and J.A. Graham, on behalf
of the Artisans Lodge; for the privilege
of using the City Hall on all Saturday
Evenings, for Lodge Meetings, for which use
they offered to pay at the rate of \$40.00 per year.

It was moved and seconded, to allow the
Hall to the Artisans, and that the City
enter into Contract; Carried.

The Council then adjourned in
due form - Wm Knight
Recorder.

The City Council Met in regular Session
on the 7th day June 1909. And was called to Order
by the President of the Council "H.C. Gillmore"
at 8:30 O'clock P.M. Mayor J.F. Witts being absent.

Present: The Recorder, Chief of Police, and
Councilmen W.H. Bair, Chas. T. Bates, S.T. Fisher,
H.C. Gillmore, J.A. Graham and H.W. Evans,
those absent at roll call: were, F.H. Hilton & C.N. Wait.

Minutes of last reg. meeting were read and stood approved.

After which the following Claims against
the City were read, Audited, and ordered
paid by six votes, of all Councilmen present:

after which: the matter of building and
repairing sidewalks: was brought up for
consideration by the City Council; and

after due consideration, The Council deemed it expedient, that New sidewalks be built along first Street, at lot No. one Block No. 2, and lot No. 1. Block. 4. and also on "C" Street along the easterly sides of lots one and twelve, in Block No. fifteen in the City of Clatsop Oregon, wherefore it was, by motion duly seconded and carried, Ordered that sidewalks be built accordingly, and that notices be served on the Owners of abutting property, in accordance with Sec. 64. of the City Charter. (at this time, Councilman F. H. Hilton appeared and took his seat in the Council.)

After which: Councilman W. H. Bair, addressed the Council, in reference to the opening and establishing of a street heretofore contemplated to be established, being an extension of C. Street, from the O. & C. R. Co's Depot grounds, through the lands of Telford & Dedman, in a southerly direction, to intersect Maple Street, for the terminus, and, after due consideration by the Council, It was ordered, by motion duly seconded, and Carried, that said street be extended and established, as heretofore contemplated, and that an Ordinance be drawn for that purpose:

The Committee on Finance was allowed until next reg. meeting to report on the matter of back rent due on lower story of City Hall, when the ex City Treasurer is expected to be present: After which, the proposed Ordinance: Preventing Cattle from running at large, was brot up, and read the second time, and by motion duly seconded was placed on its final passage: which resulted in the following vote: those voting for the passage of the Ordinance: were Councilmen, Bair, Bates Fisher Graham, Evans and president of the Council Gillmore, total 6 votes: Councilman Hilton voting No: The Ordinance was declared Passed, by President Gillmore in the Chair: After which: The Matter of Accepting the Chemical fire Engine, Contracted for, at the last Meeting: was brot up, a motion was made, duly seconded: that the Engine be Accepted: a vote was taken, which resulted as follows: Those voting Yes: were = W. H. Bair: J. A. Graham & H. C. Gillmore + three voting No. were Chas. Bates: S. J. Fisher, F. H. Hilton & H. W. Evans: Motion was declared Lost: + The Council adjourned in due form = Wm Knight Recorder.
