

Reg. Session Dec. 9<sup>th</sup> 1908.

The City Council Met in regular Session on the 9<sup>th</sup> day of Dec. 1908. and was called to order at 8 o'clock P.M. by the Mayor J. F. Mitts. Present: the Mayor, Recorder and Chief of Police; and Councilmen Bair, Wait, Sias, Fisher Hilton, and Roth. = Absent: Lucke:

Minutes of last Spcl Meeting, read & same approved, and after reading a letter from Max Telford: Stating that he would not accept the proposition in reference to moving fences and building Sidewalks and still refused to accept less than \$1000. for the land required for establishing a street as proposed. The Council proceeded to audit the following claims against the City, to wit:

There being some contention in reference to the claim of the Election board, claiming three dollars instead of two dollars each, as at former City Election; a vote was taken for the payment of same, which resulted in a vote of four to two, in favor of paying all claims, and was so ordered & Bair, Wait, Sias and Roth voting Yes; and Fisher and Hilton voting No; -

After which: in the matter of collecting Road Money from Clackamas County & Councilman W. H. Bair was requested to look after the matter & =

After which, the Ordinance granting M. J. Lee the right to construct Electric light & Power plant was read 2<sup>d</sup> time and placed on its final passage; and passed the Council by six votes; all the Councilmen present & and was so declared by the Mayor & after which: the proposed Ordinance to License certain Trades, Callings & Occupations, =

read second time, and by motion duly seconded was placed on its final passage: a vote was taken, which resulted in a vote of four to pass, and two votes against; and was declared lost: Bair: Wait: Sias, and Roth voting yes: Fisher & Hillman voted No. After which: the tax Ordinance was taken up, and ~~read~~ <sup>read</sup> 2<sup>d</sup> time, and placed on its final passage: a vote being taken which resulted in a unanimous vote of all Councilmen present to pass the Ordinance, and was so declared by the Mayor. The Mayor then immediately signed and approved the Ordinance, and the Recorder; by motion duly 2<sup>d</sup> and Carried was requested to notify the County Clerk of Clackamas County of the 5 Mill tax Levy, and have the same placed on the Clackamas Co. tax-roll for collection. After which the Council proceeded to canvass the City Election returns, The reading of the Tally-sheet of the Election held on the 7<sup>th</sup> day of Dec. 1908, in the City of Canby for City Officers; and Certified to by the Election Board: and read by the Recorder, was as follows:

The Council being satisfied in the premises, that according to the returns of said Election for City officers of Canby Oreg. Leroy D. Walker received 52 votes for City Treasurer, and for 2<sup>nd</sup> year, Chas. J. Bates rec<sup>d</sup> 56 votes; H. C. Gillmore 60, J. A. Graham 61, & Chas. N. Wait 58. For 1<sup>st</sup> year Councilman, W. H. Bair rec<sup>d</sup> 65 votes; being the highest number of votes received by said candidates, were by motion duly seconded and carried, declared duly elected and that certificates of Election be issued accordingly: — over

In the matter of Councilman Chas Lucke being absent at roll call for four consecutive Regular Meetings of the City Council; a motion was made by Councilman Wait, that the Office of Councilman Lucke be declared vacant. The Mayor declared the motion out of Order until after the adjournment of this Meeting; for the reason, that the office could not be legally declared vacant, while the 4<sup>th</sup> Meeting is still in session, at which the Councilman is alleged to be absent + after which it was moved & seconded, that the Council adjourn, to meet in special session, on the 28<sup>th</sup> day of Dec. 1908 at the usual time and place, for the transaction of unfinished business, if any, by the present Council, and such other business, as may be properly brot up, the motion was carried, and the Council adjourned +
