The City Council met on the 8th day of Sept 1908, (the first Monday in Sept. (7th) being Labor day.

and a legal Holiday, or Non judicial day,) and in the absence of the Mayor, the Meeting was called to Order at 8 O'clock P.M. by the President of the Council: W. H. Bair &

Present: The Recorder and Chief of Police, and Councilmen W. H. Bair, C. N. Wait, E. J. Sias,

S. J. Fisher F. H. Hilton and Chas J. Roth.

Absent: Councilman Chas Lucke,

Minutes of last Meeting read. & stood approved,

A Petition, was then read, signed by Leroy Walker, J. B. Howard H. A. Dedman, and 43 others, all representing to be legal residents of the City of Canby, Oreg., Addressed to the Hon. Mayor & City Council, Requesting that "C" Street, of the City of Canby, be extended from the southerly side of the O. & C. R. Co. Depot Grounds, in a southerly direction to the street known as "Mack's" or "Maple Street", and to be 80 feet in width, and conform with "C" Street of said town of Canby, &c.

And in connection with the foregoing petition, ^{here the Mayor approved & took his seat}

W. H. Bair, one of the committee on Streets & Public Property, reported (verbally) that they had interviewed the Owners of the property, in reference to establishing said road through their land, [as they were instructed to do, by the Council at the Reg. Meeting in July last, and to report] which report is: that Dr. H. A. Dedman was in favor of allowing the road to be Established

through his premises, (about 334 ft.) at a reasonable compensation but that Mr — Telford; [through whose land, the proposed road would run, and require about 264 feet in length, and 80 ft. wide]. would not agree to, nor allow the ~~road~~ proposed road to be established, at any reasonable price, or consideration for the land required to establish said proposed road, whereupon; after due consideration of the foregoing petition, and report of the Committee: it was, by Motion duly seconded and Carried, (by a rising vote of 4. for, and 2 against,) and was so declared by the Mayor that the City of Canby, hereby Authorizes the City Recorder William Knight: to make an Offer of One Hundred dollars, to Mr — Telford, for the right to open and establish said proposed Road through his premises; and it was also; by motion duly seconded and Carried that no further action be taken on said petition, until the Recorder shall hear from Mr. Telford as to whether said offer is accepted or not.

In the matter of a petition for a Street and Crosswalk, at the Depot, across R.R. track; and petition for 60 ft. road along the southerly side of the O.V.C.R.R. Depot grounds, presented and read at the July Meeting; at which meeting the Recorder was instructed to Communicate with the R.R. Officials in reference to the establishment of said Street & Crosswalk at Depot: and also the road along said Depot grounds.

The Recorder Reported that he had seen and Communicated with L.R. Fields and other R.R. Officials, who were present at the Depot, and looked over the grounds, where said Street & crosswalk; and road, were to be established; And that said L.R. Fields and Road-Master — Balland, granted, and permitted all of said improvements to be made &c.

The Recorder presented and read a Telegram from L.R. Fields, stating that they will grant the permission to improve said road & crosswalk; and that a written permit would be mailed &c. whereupon, the Telegram-permit was Accepted, and by motion duly seconded, and Carried, the Street Superintendent was instructed to go ahead with the work,

After which the following Claims against the City were read, and Audited.

Which amount was Ordered paid, by a unanimous vote of the Council present; and was so Ordered, & that Orders be drawn in favor of the above Claimants —
after which, a Bill of Costs, was presented and read, in Case of City of Canby vs. H.K. Jackson, in the Recorders Court, amounting to \$22.25 being Recorders fees — amt. \$5.65

Chief of Police " & mileage " 2.60

Witness fees & mileage — 14.00

total as per Bill, rendered \$22.25 = and after a considerable amount of debating; it was Moved and Seconded, that the Bill of Costs be laid on the Table; which resulted in a vote of 2, against; and 4, for laying on the table, Councilman Hilton and Fisher voting No, and Councilmen Bair, Wait, Sias & Roth voting Yes; and was so Ordered by the Mayor:

After which, the Claim of W. Ren & Schuebel for \$15.00 Attorneys fees for prosecuting, Sept H.K. Jackson in said Case, in Recorders Court, was presented and read, and after considering the Claim, it was Moved and Seconded that the Claim of \$15.00 attorneys fees "be not Allowed;" which motion was

Carried by a unanimous vote, & so Ordered.
After which; the following Miscellaneous matters were Ordered by motion duly Seconded and Carried:
to wit: That a sixfoot walk may be constructed, by Mrs Anna Knight, along North end of lots No. 7, 8 & 9, Blk. No. 2,
That the St. Supt is hereby instructed to see to it that all side walks, & crosswalks in the City, be fixed, & repaired where ever it may be necessary; and that Chief of Police is to see about locking up tools of the City, when not in use;

and whereas, the Recorder reported that he had deposited the Certificate of fifty Shares of Stock of the Clackamas County Fair Association with the Canby Bank & Trust Co. for safe keeping it was ordered, that said Certificate be left deposit in said Bank, until otherwise ordered and after the reading of the Lease, made and executed by & between the City of Canby and A. Kocher, leasing the lower room of City Hall to A. Kocher for another year, and accepting the same as executed. The Council adjourned in due form to meet in Special Session, if deemed necessary, during month of Sept. and at the call of the Mayor.

Reg. Meeting Oct 5th 1908.

The City Council met in regular session on the 5th day of October 1908. and was called to order by the Mayor at 8. O'clock P.

Present - The Mayor, Recorder & Chief and Councilmen Bair, Wait, Elias Fisher & Roth. Absent. Hilton and Locke. &

Minutes of last meeting read, & stood approved after which, a communication, or letter from Mr. Max Telford was read by the recorder. Reference to right of way for a street across Mr. Telford's land, extending "C" Street from depot grounds to Maple Street, - Stating that he deemed the offer of One hundred dollars for the right of way ridiculous, and that his price was One Thousand dollars for said right of way &c; Whereupon after due consideration, it was moved & seconded that the Committee on Streets & Public Property be instructed to get a written statement from Mr. H. Sedman, agreeing to exchange an equal amount of land with Mr. Max Telford, for the amount of land required for the right of way through Mr. Telford's land for said proposed street, and that the Committee make a proposition
