Reg. Meeting Oct 7th 1907.

The City Council met in Reg. Session on Monday Oct. 7th 1907. at 7:30 O'clock P.M.

Meeting was called to order by the newly elected Mayor L. D. Walker, he having been duly elected by the City Council to fill vacancy caused by the resignation of former Mayor W. L. Mack, at the last meeting. At roll call, the following Officers & members were present, to wit; Leroy D. Walker Mayor Elect, and who had previously, ^{been} duly qualified by taking and filing his Oath of Office in the office of the City Recorder; Recorder W. Knight and Chief of Police J. S. Dick; and Councilmen ^{Graham} Roth, Stogsdill, Wait, Zeck and Bair who appeared after roll call. Absent, Hampton and Riggs;

Minutes of last meeting read & stood approved, After which, the following claims against the City were presented, read, audited, and ordered paid by unanimous vote of the Council, To wit: Claim of J. S. Dick, Chief of Police Salary, Sept. 1st, \$15.00 " Wm Knight Recorder sal & fees " . - 4.35

In the matter of proposal to lay pipe lines in the city limits; M. J. Lee being present, and not being prepared to file a franchise Ordinance at this meeting, the matter was laid over to next Reg. Meeting in Nov. —

In the matter of regulating the running of trains through the City of Canby, and regarding stopping through trains at Canby, was laid over for future consideration: the matter having been presented to the R.R. Co. by Mr. M.J. Lee, who received a communication from said Co. to be further advised in the matter as soon as the R.R. Co. reaches a decision.

In the matter of repairing sidewalks, and draining ditches along block No. 1. A. East of same, it was, by motion duly seconded and carried that the Committee on St. & P.P. investigate and take whatever action is necessary to repair the same.

In the matter of New Charter, it was Moved, seconded and carried that a Specl meeting of the Council be held on Monday Oct 14th 1907. at 7.30 O'clock PM Sharp, to transact any Specie business bft before the council & to consider the adoption of the New Charter and placing the same before the legal voters for ratification at the next city election in December 1907.

In the matter application's for Saloon license of Bernroger, Jacklow, Hinton, and Churchill, for the 4th Qtr of 1907.

The Council being Satisfied in the premises that Notices had been posted, and the receipts of the City Treasures for \$100.00 Each had been filed with the City Recorder: and that Bonds had been duly Executed, and filed in the Recorders Office by each of the applicants.

It was by motion duly seconded and Carried by unanimous vote of all Councilmen present, the Bonds of said applicants be accepted, and a License granted to each applicant as prayed for. for the 4th Qtr. of 1907, and that the Recorder Issue license Accordingly - The City Treasurers Qtrly report was read and ordered placed on file + And after ordering that the Assessor & Collector should go to City, and see about collecting Road-tax, &c The Council adjourned, to meet Oct. 14th in Spec. Session.
