

The City Council met in Reg. session on the 4th day of Nov. 1907. and was called to order at 7:30 O'clock P.M. by the Mayor L. D. Walker -

Present, Mayor, Recorder and Chief of Police, and Councilmen, Bain, Graham, Hampton, Riggs, Rack, Stogsdiel, Wait and Zeek.

Minutes of last special meeting read, and then approved, after which, the matter of Road-tax due, and received, from Clackamas County, was reported by the Assessor and Collector Geo Knight to be as follows: Taxable property in Canby = 58,690, amt of Road tax at 4 mills = \$2,347.76; due Canby at fifty per. cent, \$1,173.88, delinquent last year \$153 - total due Canby from Clackamas County \$-1,189.11.

Report - accepted and placed on file, also; Ordered, that the Assessor and Collector make out a list of property-holders within the corporate limits of Canby, and present the same to County Assessor, after which, the following Claims were read and audited, and ordered - paid by unanimous vote & writ:

after which, the Council proceeded to the appointment of three Judges, and two Clerks of Election, George Meeks, Ralph C Knight and Highland W. Evans were placed in nomination for Judges, and Lewis E. Grazer, and Adam H. Knight for Clerks & No other nominations having been made, it was, by Motion duly seconded, and Carried, that the Nominees be declared the duly appointed Judges & Clerks of Election for the ensuing year, and so Ordered -

The Recorder was then directed to give ten days notice by pasting up notices in three public places in the City of the Annual Election to be held on the first Monday in Dec. 1907, at the City Hall in Canby, and to make all necessary preparation for said Election according to requirements.

Also: Ordered, by Motion duly seconded, that the Chief of Police procure a suitable Stepladder for use in the City Hall, & for other purposes;

In the Matter of appropriating One hundred dollars by the City Council, and the same amount by the County Court of Clackamas County, for the repairs of Hill road at East end of the New Bridge across Mollalla river between Canby and Barlow, was by motion duly seconded & Carried laid on the table until next Council Meeting & for further consideration;

In the Matter of the proposition to Organize a Brassband, by the Band Committee; was favorably Considered by the City Council; Provided that the probable cost of some ^{new} Secondhand instruments (about 15 pieces) would not exceed over about \$150.⁰⁰, as estimated by the Band Committee; whereupon the City Council by Motion duly seconded & Carried pledged it self to contribute a sum not to exceed seventy five dollars (\$75.⁰⁰) the band boys to pay the other one half, or more if the cost thereof should exceed one hundred & fifty dollars; and that the Committee on Streets and Public property be authorized to have the control and make proper arrangements with the band boys in Organizing the band. the band to have the use of the City Hall for practice & final arrangements to be made, subject to the approval of the City Council. —

after which the Council adjourned in due form to meet in regular session on the 4th day of Dec. 1907, at the usual hour, on account of City Election being on the 2^d day of Dec., and also, for the purpose of Canvassing the Election returns;
