The meeting was called to order at 8:05 P.M. Minutes of the May 23, 1973, meeting and the Special Meeting of June 6, 1973, were approved as read.

A notice from the Board of County Commissioners was read in regards to an appeal filed by Mr. Don Obrist of the Planning Commission's denial of his request for a Conditional Use Permit to remove gravel and operate a rock crusher on Tax Lot 100, Sec. 8, T4S, RIE, and part of Tax Lot 200, Sec. 5D, T4S, RIE. The hearing is set for Wednesday, June 20, 1973, at 10:00 A.M. in Room 201, County Courthouse, Oregon City.

First on the agenda - Public Hearing - Zone Change R-1 to R-2 - Payton/Anderson - of Parcel A, Country Club Estates, Annex #2. Public Hearing published June 6, 1973. Notices were mailed, however, the Willamette Valley Country Club was not sent a notice. A motion was made by Hulbert that the Public Hearing be postponed until June 27 at 9:00 P.M. pending notification of W.V.C.C. and remail notices. Seconded by Edgerton, carried unanimously.

Next on the agenda - Review Zone Change Application R-1 to C-2 - Joe Vraves/Guardian Properties. Chairman Ross called for Mr. Dick Brenneke of Guardian Properties, Inc., representing Mr. Joe Vraves to present the Planned Commercial Development. Mr. Brenneke presented the owner, Mr. Joe Vraves to the Commissioners. Mr. Vraves gave a resume of the project from the first application 8/25/71 to the present application relating the presentations and correspondence to the Clackamas County Planning Commission. Mr. Vraves introduced Dick Brenneke Jr. who gave statistics on the tax base, substantial growth of Canby, shopping potential, etc. Mr. Ehmann, the architect for said development, presented a design and layout of shopping area.

There was much discussion on the project between Commissioners and the representatives of the project. After discussion, a Public Hearing for a Zone Change was set for Wednesday, July 11, 1973, at 8:30 P.M.
